THIS INDENTURE is made and entered into this 31ST day of JANUARY, 1995 by and between ARNOLD GASTON MOONEY II AND WIFE, KELLY MCCARTHY MOONEY (hereinafter called the "Mortgagor," whether one or more) and AmSouth Bank of Alabama, a national banking association (hereinafter called the "Mortgagee").

## Recitals

A. The Secured Line of Credit. ARNOLD GASTON MOONEY II AND KELLY MCCARTHY MOONEY (hereinafter call the "Borrower," whether one or more) ARE now or may become in the future justly indebted to the Mortgagee in the maximum principal amount of NINETY-THREE THOUSAND EIGHT HUNDRED AND 00/100 Dollars (\$93,800.00) (the "Credit Limit") pursuant to a certain open-end line of credit established by the Mortgagee for the borrower under an agreement (the "Credit Agreement"), entitled

"AmSouth Equity Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee, dated <u>JANUARY 31</u>, 19<u>95</u>

"AmSouth Personal Financial Services Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee dated , 1995, as amended by an amendment of even date herewith

"AmSouth Premlum Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee dated , 1995, as amended by an amendment of even date herewith.

The Credit Agreement provides for an open-end line of credit pursuant to which the Borrower may borrow and repay, and repay, amounts from the Mortgagee up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.

- B. Rate and Payment Changes. The Credit Agreement provides for finance charges to be computed on the unpaid balance outstanding from time to time under the Credit Agreement at an adjustable annual percentage rate. The annual percentage rate may be increased or decreased on the first day of each billing cycle based on changes in the "Prime Rate" as published in the Wall Street Journal. The annual percentage rate charged under the Credit Agreement during each billing cycle will be 2.00% above the Prime Rate in effect on the first day of that billing cycle. The annual percentage rate on the date of this mortgage is 10.60%. The annual percentage rate will increase if the Prime rate in effect on the first day of a billing cycle increases, and will decrease if the Prime Rate in effect on the first day of a billing cycle decreases; however, the annual percentage rate will never exceed the Maximum Rate stated in the Credit Agreement. Any increase in the annual percentage rate may result in increased finance charges and increased minimum payment amounts under the Credit Agreement. Any decrease in the annual percentage rate may result in lower finance charges and iower minimum monthly payments.
- C. Maturity Date. If not sooner terminated as set forth therein, the Credit Agreement will terminate twenty years from the day of the Credit Agreement, and all sums payable thereunder (including without limitation principal, interest, expenses and charges) shall become due and payable in full.

Together with all the rights, privileges, tenements, appurtenances and fixtures appertaining to the real estate, all of which shall be deemed real Estate and conveyed by this mortgage. To have and to hold the Real Estate unto the Mortgagee, its successors and assigns forever. All judgments, awards of damages and settlements hereafter made resulting from condemnation proceedings or the power of eminent domain, or for any damage (whether caused by such taking or otherwise) to the Real Estate, or any part thereof, or to any rights appurtenant thereto, including any award for change of grade of streets, and all payments made for the voluntary sale of the Real Estate, or any part thereof, in lieu of the exercise of power of eminent domain. The Mortgagee is hereby authorized on behalf of, and in the name of, the for the voluntary sale of the Real Estate, or any part thereof, and appeal from, any such judgments or awards. The Mortgagee may apply all such sums so received, or any part thereof, after the payment of all the Mortgagee's expenses, including court costs and attorneys' fees, on the Debt in such manner as the Mortgagee elects, or, at the Mortgagee's option the entire amount or any part thereof so received may be released or may be used to rebuild, repair or restore any or all of the improvements located on the Real Estate.

The Mortgagor agrees to take good care of the Real Estate and all improvements located thereon and not to commit or permit any waste thereon, and at all times to maintain such improvements in as good condition as they now are, reasonable wear and tear excepted.
