This matter comes before the Court on the defendants' Motion to Reconsider the Summary Judgment granted previously to the plaintiff Peron, Inc. Having considered the motion and arguments of counsel the Court hereby grants the Motion to Reconsider.

Having reconsidered the plaintiff's Motion for Summary Judgment, the pleadings, and arguments of counsel the Court hereby finds that there is no genuine issues of material fact and that the plaintiff is entitled to judgment as a matter of law.
