- I, Arthur Duane Ipson, the undersigned, a Citizen, within the meaning of the Constitution of the United States of America, hereby affirm, declare and give notice that:
- I, Arthur Duane Ipson, am of lawful age and competent, am a natural born free white Citizen of the People of the Sovereign Body Politic in the state of Alabama, by virtue of birth and inheritance and thereby a Citizen within the United States of America, in fact, by right of heritage, within the state of Alabama, protected by the Constitution of the state of Alabama (1819) and by the original Constitution of the United States of America (1787), including its Preamble and the Bill of Rights (1791); retain unalienable rights of God, in positive law embodied in the Declaration of Independence (1776), binding upon myself and my parentage, this day and for all time; and,

STATEMENT OF ORIGINAL STATUS

- I, Arthur Duane Ipson, a free white Citizen of the People of the Sovereign Body Politic in the state of Alabama, was born on or about November 19, 1947 in the county of Yavapai, in the state of Arizona, a State of the United States of America; and,
- I, Arthur Duane Ipson, was sired by Harmon Wilhelm Ipson, a Citizen, within the meaning of the Preamble to and the Constitution of the United States of America, and thereby a member of the Sovereign Body Politic, in the state of Oklahoma, born on or about May 31, 1925, in the county of Dewey, in the state of Oklahoma, a State of the United States of America; and,
- I, Arthur Duane Ipson, was given birth by Jerry Dean Proffit, a free white Citizen of the Sovereign Body Politic, in the state of Washington, born on or about March 12, 1929, in the county of Dewey, in the state of Oklahoma, a State of the United States of America; and,
- Harmon Wilhelm Ipson and Jerry Dean Proffit were one, joined in the state of Holy wedlock at the time Arthur Duane Ipson was natural born to them; and,

STATEMENT OF CAUSE

- The Motor Vehicle Certificate of Title, License and Registration has lost its original espoused purpose to recover stolen property, is now an instrument of the statutory subdivision of the state of Alabama in its corporate capacity and is used to transfer true Bills of Sale to said subdivision of the state of Alabama, and is no longer within the common law jurisdiction pursuant to the original purpose of government to protect the Life, Liberty and Property of the Citizens; and,
- The Motor Vehicle Certificate of Title, License and Registration are deployed through misrepresentation, to impair, extort and divest me of my God-given Inalienable Rights, including, but not limited to, my rights to locomotion and property, through uninformed, implied and/or other consent obtained from me without revealing to me the implications of such consent, now being a stealthy encroachment on my rights as a Citizen (i. e., member of the Posterity) to have and hold true property and full fledged rights of property in my

property, without which my status as a Citizen in the state of Alabama would be, and is, impaired, and specifically subjects me to the statutory jurisdiction of agencies, officers, employees, assignees, and other affiliates, that continually act in trespass of the limitation(s) of the original Constitution of the United States of America (1787) and its Bill of Rights (1791) in violation of God's law and statutes, imposing the evils denounced by The Declaration and Resolves of the First Continental Congress (1774) and the Declaration of Independence (1776); and,

- 8. Only by my consent can the government or its constituents exercise statutory authority over me or my property outside the Constitution of the United States of America (1787) and the Bill of Rights (1791) or outside the Constitution of Alabama (1819); and,
- All power (right) lies within me to accept or deny control in areas of law which lie within the statutory jurisdiction, outside the Constitution of the United States of America (1787) and the original constitutions for the several States, that could pertain or attempt to pertain to me, as one of "the Posterity" of the Preamble to the Constitution of the United States of America (1787), which right is protected by the 9th Article of the Bill of Rights (1791), Article IV Section 4 and Article I section X of the Constitution of the United States of America (1787) and the Declaration of Independence (1776); and,
- The application for, and Notor Vehicle Certificate of Title, License and Registration do not contain any warning, whatsoever, that any rights are being waived or that a privilege is being obtained instead of my vested rights, nor does said application set forth the conditions thereof or indicate where those conditions may be found; and,
- I was deceived into believing that application for and issue of a Vehicle License, Registration and Certificate of title are a legitimate function of the governmental agency issuing same, and, that I was, or could be, required to execute same in order to exercise my rights to locomotion, have access and egress, and to own and use property in the form of a private automobile; and,

RESCISSION FOR CAUSE

- WHEREFORE, let it be known, that I, Arthur Duane Ipson, a natural born free white Citizen of the People of the Sovereign Body Politic in the state of Alabama by virtue of birth and inheritance and thereby a Citizen within the United States of America, a de jure Co-Heir to the Organic Law; in fact having fully considered my uninformed consent and submission to application for and license and registration on vehicle https://www.nascose2; will hereafter assume full responsibility for the property previously identified, while exercising full right of ownership, as protected by the Declaration of Independence (1776), and for the aforementioned cause, fully and completely, hereby RESCIMD and CANCEL all uninformed, implied or direct consent and power of agency which may have been conferred by said application for and license, registration and certificate of title; and from this day and for all time let it be known that the government of the state of Alabama will hereafter be in trespass of my rights, which are protected by the Organic Law of these United States of America, and in excess of the limitations set forth in the 9th and 10th Articles in Amendment to the Constitution of the United States of America (1787), whenever attempting to exercise the aforementioned statutory authority over me; and,
- WHEREFORE, formal notice is also hereby given, that I, Arthur Duane Ipson, repudiate all statutory special benefits and obligations of the aforesaid application for and Certificate of Title, License and Registration; That I absolutely will not use accounts established thereunder, identifying numbers or other identifiers, which represent said account, except to repudiate same; and, that I will not apply for, receive, collect, or attempt to apply for, receive, or collect, any privilege or benefits established under said License, whatsoever; and, that said application for and Certificate of Title, License and Registration will be treated as though it never had been established, fully and completely as if same had never been applied for or assigned; and,

INTENT

My intent is to be a free, Lawful, Natural American Citizen and Co-Heir to the Organic Law as stated in The Declaration of Independence (1776) and as restated in the Preamble to the Constitution of the United States of America (1787), which I am in fact by said Organic Law; to claim my God-given Rights declared by the Statute of 1776, and the limitations on government set forth in the original Constitution of the United States of America (1787), and its Bill of [Limitations] Rights (1791) and the Constitution of the state of Alabama (1819); and to reestablish myself as an American Citizen (de jure), pursuant to my rights as a Co-Heir to the Statute of 1776 and the Organic Law, to the end of preserving the Christian Republic of the United States of America as formed, and limited, by the Constitution of the United States of America (1787) the Constitution of the state of Alabama (1819), and further limited by the Bill of Rights (1791); and,

NOTICE TO TRESPASSERS

- This is notice to all who would subject me to a deprivation of my rights and corresponding responsibility, as an American Citizen pursuant to the Statute of 1776 (The Declaration of Independence). All claimants have 30 days from the date of this "Notice by Affidavit" to make any claims such claimants may wish to assert in a Court of law of Article III judicial authority; failure to do so is an admission of estoppel and laches upon all comers. Any further deprivation of my vested rights as an American Citizen by any governmental agent(s) or agency(ies) will be, by its taking place, a declaration of Mixed War between codified statutory law and common law, waged against me, by whatever person or entity who might commit such trespass, and will be remedied by whatever action is necessary and lawful taking into account the moral gravity of the deprivations in the particular instance; and,
- The statements and information contained herein are true and correct to the best of my knowledge; are set forth for cause, superseding all denials aforementioned made to date; and my signature and seal hereafter are the voluntary act of my own hand; and,

FURTHER AFFIANT SAITH NOT.
