

I, Arthur Duane Ipson, the undersigned, hereby affirm and declare that:

1. I am a Citizen, within the meaning of the Constitution of the United States of America, making this affirmation; and,
2. I, Arthur Duane Ipson, a natural born free white Citizen of the People of the Sovereign Body Politic in the state of Alabama, by natural birth and inheritance, and thereby a Citizen within the United States of America, am of lawful age and competent to make this affirmation; and,
3. I am temporarily sojourning in the county of Shelby, the 18th Judicial Circuit, in Alabama; and,
4. I am not a citizen, inhabitant, subject, or resident of the District of Columbia, its territories, or its political subdivisions and/or other affiliates; and I am not a member of the armed forces of any government; and,
5. I hereby assert the Right of Article IV, Section II, of the Constitution of the United States of America inviolable, to wit:
"The Citizens of each State shall be entitled to all privileges and immunities of Citizens in the several States..."; and,
6. I hereby assert the limitations of Article I, Section X, of the Constitution of the United States of America inviolable, to wit:
"No State shall ... make any Thing but gold and silver Coin a Tender in Payment of Debt;... ."; and,
7. I hereby assert and state that I will only handle, possess, or otherwise use Federal Reserve Notes as a Tender in Payment of Debts, under threat, duress and coercion, with all my unalienable and inalienable Rights including those enumerated above, reserved; and,
8. This claim asserts the above limitations and Rights on all States of the Union, its officers, agents, assigns, affiliates and counterparts whomever, according to my status as a Citizen of the People of the Sovereign Body Politic as set forth above; and,
9. This claim asserts the above limitations and Rights on the United States of America, its officers, agents, assigns, affiliates and counterparts whomever, according to my status as a Citizen of the People of the Sovereign Body Politic as set forth above; and,
10. The facts stated herein are true and correct to the best of my knowledge and submitted in good faith; and,






