KNOW ALL MEN BY THESE PRESENTS, That in consideration of **THREE HUNDRED FIFTEEN THOUSAND THREE HUNDRED Dollars and No/100's (\$315,300.00)** to the undersigned grantor, **Crystal Homes, Inc.**, a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell, and convey unto **ROY AUSTIN SMITH, III and SUSAN JONES SMITH** (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**:
