The above described property does not constitute the homestead of the grantor nor his spouse.

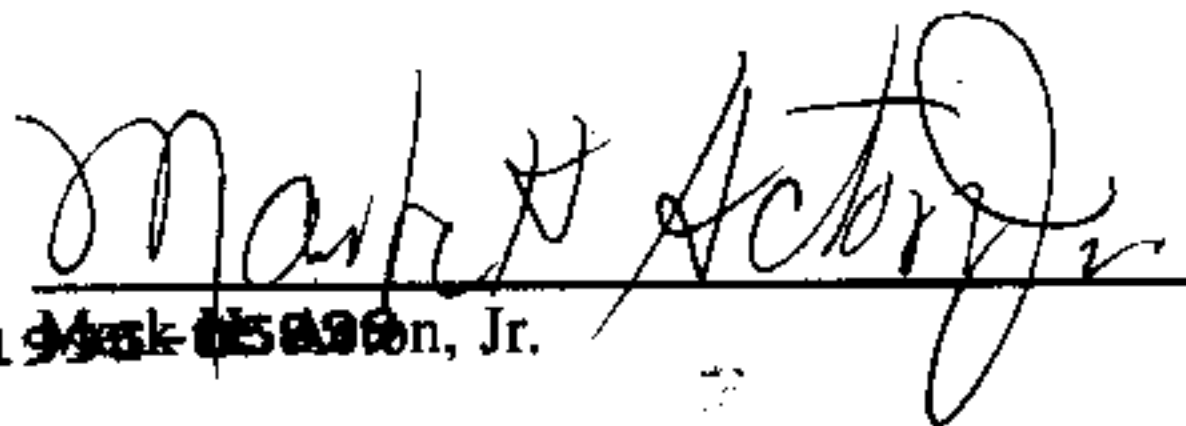
