Shally medical Center of Theile Patel with loss, if any, payable to Mortgagee as Mortgage's interest may appear, and to promptly deliver said policies, or any renewal of said policies to Mortgagee; and if the undersigned fails to keep the property insured as above specified, or fails to deliver said insurance policies to Mortgagee, the Mortgagee, or Mortgagee's assigns, may at Mortgagees option insure the real estate for said sum, for the Mortgagee's own benefit, the policy if collected to be credited on the indebtedness, less cost of collection of same.
