ARTICLES OF INCORPORATION OF TEAM REALTY, INC.

The undersigned, acting as incorporators of a corporation under the Alabama Business Corporations, Act, adopt the following articles of incorporation for such corporation:

FIRST: The name of the corporation is Team Reality, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- 1. To engage in the purchase, sale and development of real property, and to invest money in all kinds of property, both real and personal, to buy, sell, own and deal in securities of all kinds and to act as "Real Estate Broker."
- 2. To carry out or exercise amy business hereunder under it's own or valid trade name adopted by it.
- 3. To borrow and lend money, with or without security, and to mortgage, pledge, or hypothecate any property the corporation may own, regardless of its nature or the evidence of same.
- 4. To develop, acquire, sell, lease and own, real, personal and mixed property of all kinds, and to build and remodel apartments, condominiums, single-family housing, or commercial buildings of every kind and descriptions; and to promote, organize and control land companies; and to provide interior design and remodeling services, including construction services and to provide equipment by sale or lease, to hotels, motels, office and other commercial or residential buildings and to promote, organize and control other corporations or partnerships to engage in amy business activity authorized by these articles.
- 5. To improve, manage, develop, sell, assign, transfer, lease, mortgage, pledge or otherwise dispose of or turn to account or deal with all or any part of the property, real or personal, of the corporation and, from time to time, to vary any investment or employment of capital of the cooperation.

- 9. To acquire by purchase, subscription, or otherwise, and to hold or dispose of, units, shares, bonds or any other obligations of any corporations or limited or general partnership interest in any limited partnership formed for, or then or therefore to engage in or pursuing any one or more of the kinds of businesses, purposes, objects or operations above indicated, or owning or holding any property of any kind herein mentioned; or of any corporation owning or holding the shares of the obligations of any such corporation.

Without in any manner limiting any of the objects and powers of the corporation, it is hereby expressly declared and provided that the corporation shall have power to issue bonds and other obligations, in payment for property purchased or acquired by it, or for any other object in or about its business; to create a security interest in or pledge any units, shares, bonds, or other obligations, or any property which may be acquired by it; to secure any bonds or other obligations by it issued or incurred; to guarantee any dividends or bonds or contracts or other obligations; to make and perform contracts of any kind and description; to purchase, lease, own, and use lands for any purpose of the corporation and in carrying on its business, or for the purpose of obtaining or furthering any of its objects, to do any and all other acts and thins, and to exercise any and all other powers which a co-partnership or natural person could do and exercise, and which may now or hereafter by authorized by law.
- 12. To transact any and all lawful business for which corporations may be incorporated under Title 10 of the Code of Alabama of 1975, as the same may from time to time be amended, or any subsequent reenactment or recodification of the same, as the same may from time to time be amended, doing and performing all the acts and enjoying all of the powers conferring upon corporations by general laws of Alabama.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are: NONE unless and until by-laws are adopted.
