





Commence at the Northeast corner of the Northwest 1/4 of the Southwest 1/4 of Section 35, Township 19 South, Range 1 West, being the Point of Beginning and run South along east line of said 1/4-1/4 section 664.11 feet; thence turn 88 degrees 03 minutes 50 seconds right and run 451.25 feet; thence turn 91 degrees 53 minutes 37 seconds right and run 1167.21 feet; thence turn 88 degrees 02 minutes right and run 439.71 feet to the P.C. of a curve to the left, having a central angle of 25 degrees 28 minutes 10 seconds and a radius of 424.95 feet and run along the arc of said curve 187.35 feet; thence turn 104 degrees 36 minutes 58 seconds right from extended chord and run 545.25 feet; thence turn 88 degrees 12 minutes 58 seconds right and run 169.97 feet to the Point of Beginning.
