KNOW ALL MEN BY THESE PRESENTS, That in consideration of **TWO HUNDRED FOURTEEN THOUSAND NINE HUNDRED Dollars and No/100's (\$214,900.00)** to the undersigned grantor, **Ever-Ridge Builders, Inc.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of which is hereby acknowledged, the said **GRANTOR** does by these presents, grant, bargain, sell, and convey unto **J. EDWARD MCGOLRICK and ANNADEL MCGOLRICK** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**:

Lot 18, according to the Survey of The Highlands, 2nd Sector, as recorded in Map Book 18, Page 48, in the Probate Office of Shelby County, Alabama.

Subject to:
