- Together with all essements, rights of way, gores of land, streets, ways, alleys, passages, sewer rights, waters, water courses, water rights and powers, and all estates, lesses, subleases, licenses, rights, titles, interests, privileges, liberties, tenements, hereditements, and appurtenances whatsoever, in any way belonging, relating or apportaining to any of the property hereinabove described, or which hereafter shall in any way belong, relate or be appurtenant thereto, whether now owned or hereafter acquired by the florrower, and stighteversion and reversions, remainder and remainders, rems, issues and prefits thereof, and all the estate, right, title, interest, property, possession, claim and demand whatsoever at law, as wall as in equity, of the Borrower of, in and to the same, including but not limited to:
 - All rents, revolties, profits, issues and revenues of the Land and improvements from time to time accruing, whether under lesses or tenancies now existing or hereafter prested; and
 - All judgments, awards of damages and settlements hereafter made resulting from condemnation proceedings or the taking of the Land and improvements or any part tiereof under the power of eminent domain, or for any damage (whether caused by suph taking or otherwise) to the Land and improvements or any part thereof, or to any rights appurtenant thereto, including any award for change of grade or streets. Lender hereby is authorized on behalf of and in the name of Borrower to execute and deliver veild acquittances for, and appeal from, any such judgments or awards. Lender may apply all such sums or any part thereof so received, after the payment of all its expenses, including costs and attorneys' fees, on any of the indebtedness secured hereby in such manner as it elects or, at its option, the entire amount or any part thereof so received may be released;
- All cash and non-cash proceeds and all products of any of the foregoing items or types of property described in (a), (b), (c) or (d) above, including, but not limited to, all insurance, contract and tort proceeds and claims, and including all inventory, accounts, chattel paper, documents, instruments, equipment, (between, consumer goods and general intengibles acquired with cash proceeds of any of the foregoing items or types of property described in (a), (b), (c) or (d) above.

TO HAVE AND TO HOLD the Mortgaged Property and all parts thereof unto the Lender, its successors and essigns forever, subject, however, to the terms and conditions herein;

PROVIDED, HOWEVER, that these presents are upon the condition that, (i) if the Borrower shall fully pay or cause to be fully paid to the Lender the principal and interest payable with respect of the Loan and the Note, and any extensions, renewals, modifications and refinencings of same, at the times and in the manner stipulated therein and herein, all without any deduction or credit for taxes or other similar charges paid by the Borrower, and shall pay all charges incurred herein by Lender on account of Borrower, including, but not fimited to, attorneys' fees, and shall pay any and all Other indebtedness, and shall keep, perform and observe all and singular the covenants, conditions and agreements in this Mortgage, in the Note, in the other Loan Documents, and in the Other Indebtedness Instruments expressed to be kept, performed, and observed by or on the part of the Borrower, all without freud or dalay, and (ii) the Lender shall have no further commitment or agreement to make advances, incur obligations or give value under the Loan, the Note, any other Loan Document or any Other Indebtedness Instrument (including without limitation advances, obligations or value relating to future advances, open-end, revolving or other lines of credit or letters of credit), then this Mortgage, and all the properties, interests and rights hereby granted, bargained, sold and conveyed shall case, terminate and be void, but shall otherwise remain in full force and effect.

AND the Borrower further represents, warrants, covenants and agrees with the Lender as follows:

ARTICLE I GENERAL

- 1.01 Performance of Mortgege, Note and Loan Documents. The Borrower shall perform, observe and comply with all provisions hereof, of the Note, of the other Loan Documents, and of the Other Indebtedness Instruments, and shall duly and punctually pay to the Lender the sum of money expressed in the Note, with interest thereon, and all other sums required to be paid by the Borrower pursuant to the provisions of this Mortgage, of the Note, of the other Loan Documents, and of the Other Indebtedness Instruments, all without any deductions or credit for taxes or other similar charges paid by the Borrower.
- 1.02 Warranty of Title. Borrower hereby warrants that it is lawfully saized of an indefensible estate in fee simple in the land and real property hereby mortgaged, or is lawfully seized of such other estate or interest as is described on Exhibit A hereto, and has good and absolute title to all existing personal property hereby granted as security, and has good right, full power and lawful authority to sell, convey, mortgage and grant a security interest in the same in the manner and form aforesaid; that the same is free and clear of all grants, reservations, security interests, liens, charges, and encumbrances

whatsoever, including, as to the personal property and fixtures, conditional sales contracts, chattel mortgages, security agreements, financing statements, and anything of a similar nature, and that Borrower shall and will warrant and forever defend the title thereto and the quiet use and enjoyment thereof unto the Lender, its successors and assigns, against the lawful claims of all persons whomsoever.

1.03 Feture Advances, Revolving and Open-End Loans, and Other Debts. It is expressly understood that this Mortgage is intended to and does secure not only the Loan, but also future advances and any and all Other indeffections, obligations and liabilities, direct or contingent, of the Borrower to the Lender; whether now existing or himselfer srising, and any and all extensions, renewals, modifications and refinencings of same, or any part thereof; existing at any time before actual cancellation of this instrument on the probate records of the country or counties Where the Wortgaged Property is located, and whether the same be evidenced by note, open appount, subignment, endorselfient, guaranty, pledge or otherwise. The Loan and the Other Indebtedness may, if provided in the applicable loan instruments, provide for Nevalving or open-and loans and advances, all of which shall be secured by this Mortgage.

1.04 Monthly Tax Deposit. If required by Lender, Borrower shall pay on the first-day of each month one-twelfth (1/12) of the yearly taxes on the Mortgaged Property, as estimated by Lender, in addition to such regular installment of principal and interest. Such sums shall not draw interest and shall not be, nor be deemed to be, trust funds, but may be commingled with the general funds of Lender. Borrower agrees to pay Lender the amount of any deficiency recessary to exhibit Lender to pay such taxes when due. Such sums may be applied by the Lender to the reduction of the indebtidness ascured hereby in any memor selected by Lender if an Evant of Default shall occur under this Mortgage or under the Note, any of the other Loan Documents, or any of the Other Indebtedness instruments, but, unless otherwise agreed by the Lender in writing, no application of tax deposits to the Note, to Other Indebtedness, or to other obligations secured hereby, shall delay, reduce, after or otherwise affect any regularly scheduled payment with respect to the Loan, the Other Indebtedness, or any such other obligations.

1.05 Other Taxes, Utilities and Liens.

- The Borrower shall pay promptly, when and as due, and, if requested, will exhibit promptly to the Lender receipts for the payment of all takes, assessments, water rates, utility charges, dues, charges, fines, penalties, costs and other expenses incurred, and impositions of every nature whatsoever imposed, levied or assessed upon or against the Mortgaged Property or any part thereof or upon the revenues, rents, issues and profits of the Mortgaged Property or arising intrespect of the occupancy, use or possession thereof, enupon the interest of the Lender in the Mortgaged Property jother than any of the same for which provision has been made in Paragraph 1.04 of this Article I), or any charge which, if unpaid, would become a lien or charge upon the Mortgaged Property.
- (b) The Borrower promptly shall pay and shall not suffer any mechanic's, laborer's, statutory or other lien to be created or to remain outstanding upon any of the Mortgaged Property.
- In the event of the passage of any state, federal, municipal or other governmental law, order, rule or regulation, subsequent to the date hereof, in any manner changing or modifying the laws now in force governing the texation of mortgages or debts secured by mortgages or the manner of collecting taxes, then Botrower immediately shall play any increased taxes if allowed by law, and if Borrower falls to pay such additional taxes, or if Borrower is prohibited from paying such taxes, or if Lender in any way is adversely affected by such law, order, rule or regulation, then in any of such events, all indebtedness secured by this Mortgage and all interest accrued thereon shall without notice become due and payable forthwith at the option of the Lender.

1.08 Insurance.

- The Borrower shall procure for, deliver to, and maintain for the benefit of the Lander during the term of this Mortgage insurance policies in such amounts as the Lender shall require, insuring the Mortgaged Property against fire, extended coverage, war damage (if available), and such other insurable hazards, casualties and opntingenoles as the Lender may require. The form of such policies and the companies issuing them shall be acceptable to the Lender, and, unless otherwise agreed by the Lender in writing, shall provide for coverage without coinsurance or deductibles. All policies shall contain a New York standard, non-contributory mortgages endorsement making losses payable to the Lender, as mortgages. At least fifteen (15) days prior to the expiration date of all such policies, renewals thereof satisfactory to the Lender shall be delivered to the Lender. The Borrower shall deliver to the Lender receipts evidencing the payment of all such insurance policies and renewals. In the event of the foreclosure of this Mortgage or any transfer of this to the Mortgaged Property in partial or full extinguishment of the indebtedness, segured hereby, all right, title and interest of the Borrower, or its assigns, in and to all insurance policies then in force shall pass to the purchaser or grantee.
- The Lender heraby is authorized and empowered, at its option, to adjust or compromise any loss under any insurance policies on the Mortgaged Property, and to collect and receive the proceeds from any such policy or policies. Each insurance company heraby is authorized and directed to make payment for all such losses directly to the Lender instead of to the Borrower and Lender jointly. After deducting from said insurance proceeds any expenses incurred by Lender in the collection or handling of said funds, the Lender may apply the net proceeds, at its option, either toward repairing or restoring the improvements on the Mortgaged Property, or said credit on any portion of the Borrower's indebtedness selected by Lender, whether then matured or to mature in the future, or at the option of the Lender, such sums either wholly or in part may be used to repair such improvements, or to build new improvements in their place or for any other purpose and in a manner satisfactory to the Lender, all without affecting the lien of this Mortgage for the full amount secured hereby before such payment took place. Lender shall not be liable to Borrower or otherwise responsible for any failure to collect any insurance proceeds due under the terms of any policy regardless of the cause of such failure.

- If required by the Lender, the Bornower shall pay on the first day of each month, in addition to any regular (0) installment of principal and interest and other charges with respect to indibitedness secured hereby, and the monthly tax deposit provided for in Paragraph 1.04 hereof, one-twelfth (1/12) of the yearly premiums for insurance maintained pursuant to the provisions of this Paragraph 1.06. Such amount shall be used by Lander to pay such insurance premiums when due. Such added payments shall not be, nor be deemed to be, trust funds, but may be commingled with the peneral funds of the Lender, and no interest shall be payable in respect thereof. Upon demand of the Lender, the Borrower agrees to deliver to the Lender such additional maneys as are necessary to make up any deficiencies in the amounts deposited by Borrower with Lender pursuent to this Paragraph 1.08 to enable the Lender to pay such insurance premiums when due. In the event of an Event of Default hereunder or of a default by Borrower under the Note, any other Logo Documents, or any Other Indebtedness Instruments, the Londer may apply such sums to the reduction of the Indelitedness secured hereby in any memor selected by Lender, but, unless otherwise agreed by the Lender in writing, no application of insurance proceeds to the Loan, to Other indebtedness, or to other obligations secured hereby, shall delay, reduce, alter or otherwise affect any regularly acheduled payment with respect to the Loan, the Other Indebtedness, or any such other
- 1.07 Condemnation. If all or any part of the Mortgaged Property shall be damaged or taken through condemnation (which term when used in this Mortgage shall include any damage or taking by any governmental or private authority, and any transfer by private sale in lieu thereof), either temperarily or permanently, the entire indebtedness secured hereby shall at the option of the Lender become immediately due and payable. The Lander shall be entitled to all compensation, awards, and other payments or relief for any condemnation and hereby is authorized, at its option, to commence, appear in and prosecute, in its own or the Borrower's name, any sotion or proceeding relating to any condemniation, and to settle or compromise any claim in connection therewith. All such compensation, awards, damages, claims, rights of action and proceeds and the right thereto are hereby assigned by the Borrower to the Lender, which, after deducting therefrom all its expenses, including attorneys' fees, may release any moneys so received by it without affecting the lien of this Mortgage or may apply the same in such mariner as the Lender shall determine to the reduction of the indebtedness secured hereby, and any balance of such moneys then remaining shall be paid to the Borrower. The Borrower agrees to execute such further assignments of any compensations, awards, damages, claims, rights of action and proceeds as the Lander may require. The Borrower promptly shall notify the Lender in the event of the institution of any condemnation or eminent domain proceeding or in the event of any threat thereof. The Lander shall be entitled to retain, at the expense of the Borrower, its own legal counsel in connection with any such proceedings or threatened proceedings. Lender shall be under no obligation to the Borrower or to any other person to determine the sufficiency or legality of any condemnation award and may accept any such award without question or further inquiry.

1.08 Care of the Property.

Upon any failure by the Borrower ag to do; the Lender may make, execute, and record any and all such mortgages, instruments, certificates, and documents for and In the name of the Borrower, and the Borrower hereby irrevocably appoints the Lander the agent and attorney-in-fact of the Borrower se to do. The lien and rights hereunder automatically will attach, without further aut, to all after-acquired property (except consumer goods, other than eccessions, not acquired within ten (10) days after the Lender has given value under the Note) attached to and/or used in the operation of the Mortgaged Property or any part thereof.
- Without limitation to the generality of the other provisions of this Mortgage, including subparagraph (a) of this Paragraph 1.09, it hereby expressly is covarianted, agreed and acknowledged that the liant and rights hereunder automatically will attach to any further, greater, additional, or different extate, rights, titles or interests in or to any of the Mortgaged Property et any time acquired by the Börrower by whatsoaver means, including that in the event the Borrower is the owner of an extate or interest in the Mortgaged Property or any part thereof (such as, for example, as the lessee or tenant) other than as the fee simple owner thereof, and prior to the satisfaction of record of this Mortgage the Borrower obtains or otherwise acquires such fee simple or other estate, then such further, greater, additional, or different extate in the Mortgaged Property, or a part thereof, shall automatically, and without any further action or filling or recording on the part of the Borrower or the Lender or any other paraon or entity, be and become subject to this Mortgage and the Ben hereof. - 1.10 Additional Security. The Lender size shell have and hereby is granted a security interest in all monies, securities and other property of the Borrower, now or hereafter assigned, held, received, or coming into the possession, control, or custody of the Lender by or for the account of the Borrower (including indebtedness due from the Lender to the Borrower, and any and all claims of Borrower against Lender, at any time existing) whether expressly as collateral security, custody, pledge, trensmission, collection or for any other purpose, and also upon any and all deposit belances, including any dividends declared, or interest accruing thereon, and proceeds thereof. On an Event of Default, the Lender may, in addition to any other rights provided by this Mortgage or any of the other Loan Documents, but shell not be obligated to, apply to the payment of the Loan or Other Indebtedness secured hereby, and in such manner as the Lender may determine, any such monies, securities or other property held or controlled by the Lender. No such application of funds shell, unless otherwise expressly agreed by the Lender in writing, reduce, litter, delay or otherwise affect any regularly scheduled payment with respect to the Loan or such Other Indebtedness or obligations.

- 1.13 Performance by Lender of Defaults by Borrower. Borrower agrees to and does hereby indemnify and hold Lender harmless from all loss, cost, damage, claim and expense incurred by Lender on account of (i) the violation of any representation or warranty set forth in this Paragraph 1.17, (ii) Borrower's partial and paragraph 1.17, (iii) Borrower's or the Mortgaged Property's failure to fully comply with all environmental laws, rules and regulations, with all occupations) health and safety laws, rules and regulations, with all occupations) health and safety laws, rules and regulations, with the ADA or the Rehabilitation Apt, as applicable, or (iv) any other matter related to environmental or physical conditions on, under or affecting the Mortgaged Property. This indemnification shall survive the closing of the Loan, payment of the Loan, the exercise of any right or remedy under any Loan Document, and any subsequent sale or transfer of the Mortgaged Property, and all similar or related events or occurrences. In the exercise of the powers herein granted the Lender, no Hability shall be asserted or enforced against the Lender, all such Hability being expressly waived and released by the Borrower.
- 2.04 Present Assignment. Should the Lander incur any such liability, loss or demands, under said leases or under or by reason of the assignment thereof, or in the defense of any claims or demands asserted against the Lender in connection with any one or more of said leases, sublesses or agreements, the Borrower agrees to reimburse the Lender for the amount thereof, including costs, expenses and reasonable attorneys' fees small be secured by the assignment hereunder and by this Mortgage.
- 2.06 Instruction to Leasure. The Borrower does further specifically authorize and instruct each and every present and future leasure, tenant, sublesses or subtenant of the whole or any part of the Mortgaged Property to pay all unpaid rental agreed upon in any lease, sublesse or tenancy to the Lender upon receipt of demand from said Lender to pay the same.

2.07 Default (Assignment). Borrower promptly shall notify Lander of any change in the location of the Colleteral. Except for transactions in the ordinary course of Borrower's business, Borrower, its agents or employees, will not remove the Colleteral from said location without the prior written consent of the Lender;

If at any time or times by sale, essignment, negotiation, pledge, or otherwise, Lender transfers any or all of the indebtedness or instruments secured hereby, such transfer shell, unless otherwise specified in writing, carry with it Lander's rights and remedies hereunder with respect to such indebtedness or instruments transferred, and the transferse shell become vested with such rights and remedies whether or not they are specifically referred to in the transfer. If and to the extent Lender retains any of such indebtedness or instruments, Lender shell continue to have the rights and remedies herein set forth with respect thereto.
- 3.06 No Obligation of Lander Under Assigned Contracts. The Lender shall not be obligated to perform or discharge, nor does it hereby undertake to perform or discharge, any obligation, duty or liability under any contracts or agreements relating to the Mortgaged Property., and the Borrawer shall and does hereby agree to indemnify and hold the Lender harmlass of and from any and all liability, loss or damage which it may or might linear under any such contracts or agreements or under or by reason of the assignment thereof and of and from any and all claims and damands whatsoever which may be asserted against it by reason of any alleged obligations or undertakings on its part to parform or discharge any of the terms, opygnents or agreements contained in said contracts or agreements. Should the Lender incur any such liability, loss or damage, under said contracts or agreements or under or by reason of the assignment thereof, or in the defense of any oblights or demands asserted against the Lender in connection with any one or more of said gontracts or agreements, the Borrower agrees to reimburse the Lender for the amount thereof, including costs, expenses and reasonable actomays' less immediately upon demand, and until the same are fully reimbursed by the Borrower, all such costs, expenses and attorneys' fees shall be secured by the assignment hereunder and by this Mortgage.
- 3,07 Defenit (Security Agreement). Upon the occurrence of any Event of Default, as described in Paragraph 4.01 of this Mortgage, the Lender shall have all rights and remedies set forth in Article IV or elsewhere in this Mortgage.

EVENTS OF DEFAULT AND REMEDIES

 - The entry by a court of competent jurisdiction or any order, judgment, or decree approving a petition filled against the Borrower or any guarantor of any of the indebtedness secured hereby or of any of Borrower's obligations hereunder, seeking any reorganization, arrangement, composition, readjustment, liquidation, dissolution or similar railed under any present or future federal, state or other statute, law or regulation relating to benkruptcy, insolvency or other relief for debtors, which order, judgment or decree remains universated and unstayed for an aggregate of thirty (30) days (whether or not consecutive) from the date of entry thereof, or the appointment of any trustee, receiver or liquidator of the Borrower or any such guarantor or of all or any substantial part of the Mortgaged Property or of any or all of the rents, revenues, issues, earnings, profits or income thereof, or of any interest or estate therein, without the consent or acquiespence of the Borrower and/or any such guarantor which appointment shall remain universated and unstayed for an apgregate of thirty (30) days (whether or not consecutive); or
 - (a) The filling or enforcement of any ather mortgage, lien or encumbrance on the Mortgaged Property or any part thereof, or of any interest or estate therein; or
 - If any portion of the Mortgaged Property is a leasehold estate, the occurrence of a default under such lease or other instrument creating the estate.
- 4.02 Acceleration of Maturity. If an Event of Défault shall have occurred, then the entire balance of the indebtedness (including but not limited to the Loan and the Other indebtedness) secured hereby (or such parts as Lender may elect) with interest accrued thereon (or such parts as Lender may elect) shall, at the option of the Lender, become due and payable without notice or demand, time being of the essence: Any emission on the part of the Lender to exercise such option when entitled to do so shall not be considered as a wallver of such right.
- 4.03 Right of Lunder to Enter and Take Possession.

 - Upon every such entering upon or taking of possession, the Lander, as attorney-in-fact or agent of the **(6)** Borrower, or in its own name as mortgages and under the powers herein granted, may hold, store, use, operate, manage and control the Mortgaged Property (or any portion thereof selected by Lender) and conduct the business thereof either personally or by its agents, and, from time to time (i) make all necessary and proper maintenance, repairs, renewals, replacements, additions, betterments and Improvements thereto and thereon and purchase or otherwise acquire additional fixtures, personalty and other property; (ii) insure or keep the Mortgaged Property (or any portion thereof selected) by Lander) Insured; (iii) manage and operate the Mortgaged Property (or any portion thereof selected by Lender) and exercise all the rights and powers of the Borrower in its name or otherwise, with respect to the same, Including legal actions for the recovery of rent, legal dispossessory actions against tenants holding over and legal autions in distress of rent, and with full power and authority to cancel or terminate any leave or sublease for any pause or on any ground which would entitle the Borrower to cancel the same, and to elect to disaffirm any lease or sublesse made subsequent to this Mortgage or subordinated to the Ken hereof; (iv) enter into any and all agreements with respect to the exercise by others of any of the powers herein granted the Lender, all as the Lander from time to time may determine to be to its best advantage; and the Lender may collect and receive all the income, revenues, rents, issues and profits of the Mortgaged Property (or any portion thereof selected by Lender), including those past due as well as those accruing thereafter, and, after deducting (ea) all expenses of teking, holding, managing, and operating the

- 4.08 Lendar's Option on Foreclosure. At the option of the Lender, this Mortgage may be foreclosed as provided by law or in equity. In which event a reasonable attorneys' fee shall, among other costs and expanses, be allowed and paid out of the proceeds of the sale. In the event Lander exercises its option to foreclose this Mortgage in equity. Lender may, at its option, foreclose this Mortgage subject to the rights of any tenants of the Mortgaged Property, and the failure to make asserted to be by the Borrawer, a defense to any proceedings instituted by the Lender to collect the sums secured hereby, or to collect any deficiency remaining unpaid after the foreclosure sale of the Mortgaged Property.
- 4.10 Walver of Exemption. Borrower walves all rights of exemption pertaining to real or personal property as to any indebtedness secured by or that may be secured by this Mortgage, and Borrower walves the benefit of any statute regulating the obtaining of a deficiency judgment or requiring that the value of the Mortgaged Property be set off against any part of the Indebtedness secured hereby.
- 4.11 Bults to Protect the Mortgaged Property. The Lander shall have power (a) to institute and maintain such suits and proceedings as it may deem expedient to prevent any impairment of the Mortgaged Property by any acts which may be uniawful or in violation of this Mortgage; (b) to presieve or protect its interest in the Mortgaged Property and in the income, revenues, rents and profits erising therefrom; and (c) to restrain the enforcement of or compliance with any legislation or other governmental enautment, rule or order that may be unconstitutional or otherwise invalid, if the enforcement of or compliance with such enautment, rule or order would impair the security hereunder or be prejudicial to the interest of the Lender.
- 4.12 Borrower to Pay the Note on any Default in Payment; Application of Moneys by Lender. If default shall occur in the payment of any amount due under this Mortdage, the Note, any of the other Loan Documents or any of the Other Indebtedness instruments, or if any other Event of Default shall occur under this Mortdage, then, upon demand of the Lender, the Borrower shall pay to the Lender the whole amount due and payable under the Note and under all Other Indebtedness Instruments; and in case the Borrower shall fail to pay the same forthwith upon such demand, the Lender shall be entitled to sue for and to recover judgment for the whole amount so due and unpaid together with costs, which shall include the reasonable compensation, expenses and disbursaments of the Lender's agents and attorneys.
- A.13 Delay or Omission No Walver. No delay or omission of the Lender or of any holder of the Note to exercise any right, power or remedy accruing upon any default shall exhaust or impair any such right, power or remedy or shall be construed to be a walver of any such default, or acquiescence therein; and every right, power and remedy given by the Note, this Mortpage, any of the other Loan Documents, or the Other Indebtedness instruments to the Lender may be exercised from time to time and as often as may be deemed expedient by the Lander.
- 4.14 No Waiver of One Default to Affect Another. No waiver of any default hereunder, under any of the other Loan Documents, or under any of the Other Indebtedness instruments shall extend to or shall effect any subsequent or any other then existing default or shall impair any rights, powers or remedies consequent thereon.
