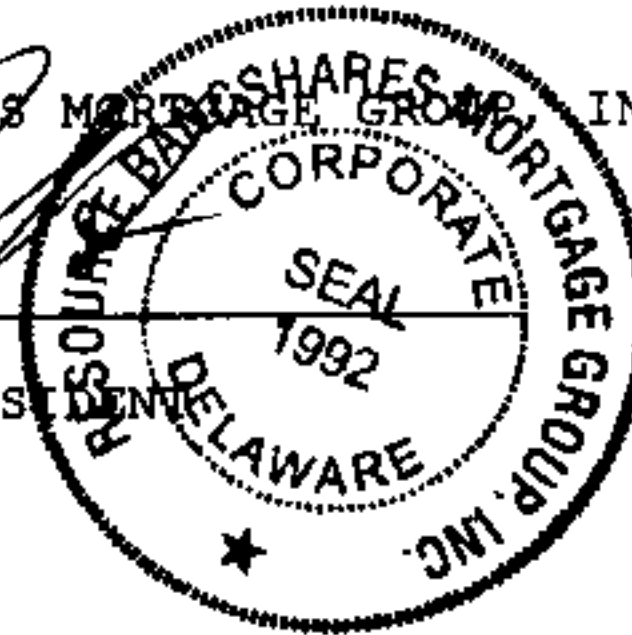
# ASSIGNMENT OF MORTGAGE

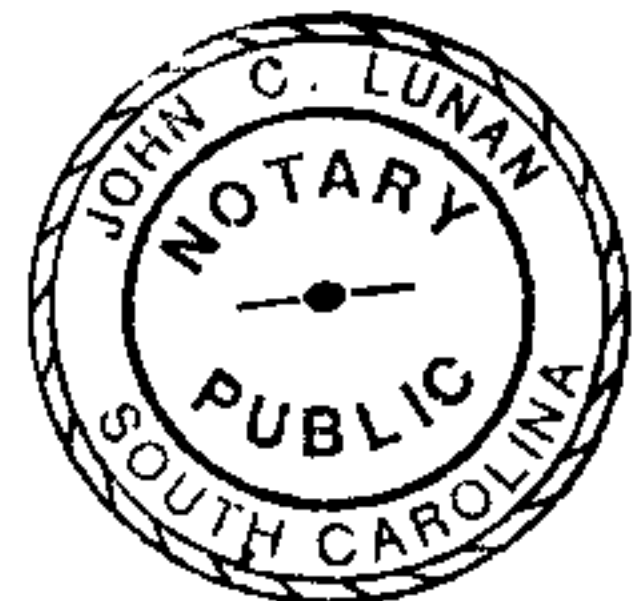
