**ARTICLES OF INCORPORATION**

The undersigned incorporator, pursuant to the provisions of the Alabama Business Corporation Act, does hereby adopt and authorize the filing of these Articles of Incorporation, with the following provisions:

1. The name of the corporation is: Christian Business Computing, Inc.
2. The period of duration shall be perpetual.
3. The purpose or purposes for which the corporation is organized shall be the transaction of any or all lawful business for which corporations may be incorporated under said Act, and the corporation shall be and is hereby expressly authorized so to do. Without limitation said purposes shall include the following: (a) Each and every lawful business, commercial, manufacturing, construction, service, financial, investment, transportation, mining, sales, purchase, agency, brokerage and management activity not specifically prohibited to this corporation under the laws of the United States or the State of Alabama; and (b) any and all aspects of the development, sale and distribution of computer software and merchandise related to religious business sales, service and merchandising.
4. The aggregate number of shares which the corporation shall have the authority to issue shall be 5,000, all of which shall consist of one class of common stock. The par value of each of such shares shall be \$1.00.
