

ORDINANCE

Whereas on the 27th day of February 1995, LEON CURRY and wife ELIZABETH ANN CURRY filed a petition with the City of Clerk of the City of Calera as required by Sections 11-42-20 and 11-42-21, Code of Alabama 1975, petitioning and requesting that the property hereinafter described be annexed to the municipality of the City of Calera, Alabama and requesting the mayor and Council of said city to adopt an ordinance assenting to the annexation of said property to such municipality, which petition contained an accurate description of the property or territory proposed to be annexed together with a map of the said territory showing its relationship to the corporate limits of the City of Calera, and the signatures of the owners of the property or territory described were signed thereto;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF CALERA, ALABAMA, AS FOLLOWS:

That the City of Calera does adopt this ordinance assenting to the annexation of the following described property or territory to the municipality of the City of Calera. Said property being described as follows:

One acre in the NW 1/4 of the SW1/4 pf Section 2, Township 24, Range 13 East, described as follows: Begin at the Northeast corner of the NW1/4 of SW1/4, Section 2, Township 24, Range 13 East, and run West 363 feet to the point of beginning; thence South 210 feet; thence West 210 feet, thence North 210 feet; thence East 210 feet to the point of beginning.

Be it further ordained that the corporate limits of the City of Calera be extended and rearranged so as to embrace and include such property and such property or territory shall become a part of the corporate area of such municipality upon the date of publication of this Ordinance, as provided for in Sections 11-42-20 and 11-42-21, Code of Alabama 1975.

Be it further ordained that the City Clerk be and she is hereby authorized and directed to file a copy of this ordinance, along with an accurate description of the property or territory being annexed, together with a map of the said territory showing its relationship to the corporate limits of the City of Calera to which said territory is being annexed, in the office of the Judge of Probate of Shelby County, Alabama

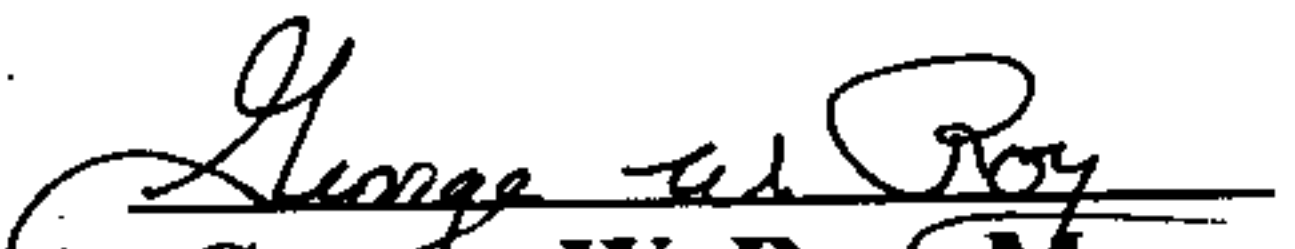
Be it Ordained that said property shall be annexed with the temporary zoning classification of MR (Municipal Reserve) until permanent classification is determined by the procedures of zoning as outlined in the City of Calera Zoning Ordinance.
