ONE: The "Motion To Continue" is denied.



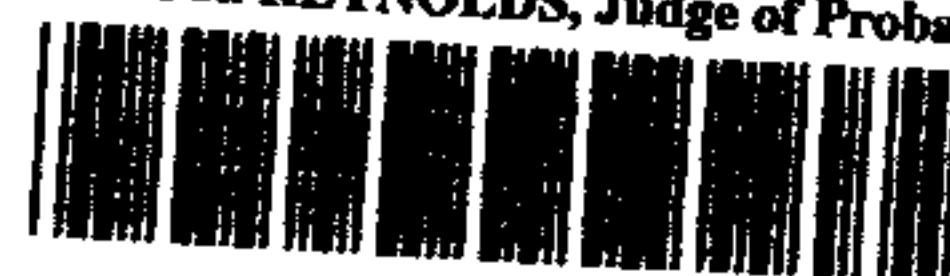
