KNOW ALL MEN BY THESE PRESENTS, That in consideration of **FOUR HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED Dollars and No/100's (\$458,400.00)** to the undersigned grantor, **Vista Homes, Inc.**, a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell, and convey unto **KERRY E. ADAMS and DIANE C. ADAMS** (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

Lot 10, according to the Survey of Greystone, 7th Sector, as recorded in Map Book 18, Page 119, in the Probate Office of Shelby County, Alabama.
