Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.

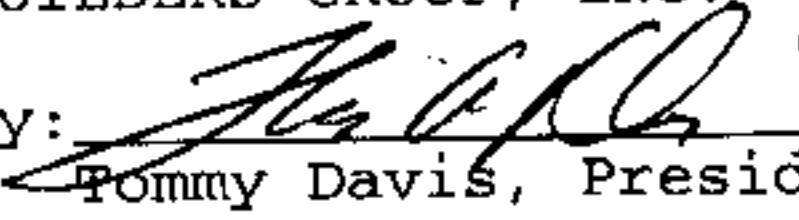
\$88,901.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.
