A. GRANT KNOW ALL MEN BY THESE PRESENTS, That Nancy Harrison Gray; A
married female, Helen Harrison Phillips, An unmarried female, Carol H.

as grantor(s), (the "Grantor", whether one or more) for and in consideration of One and No/100 Dollars (\$1.00), and other good and valuable consideration to Grantor in hand paid by Alabama Power Company (the "Company"), a corporation, the receipt and sufficiency of which are hereby acknowledged, does hereby grant to the Company, the easements, rights and privileges described and designated in Section B below, together with the right to permit othe persons, partnerships and corporations to use and exercise such easements, rights and privileges in common with the Company.
B. RIGHTS The easements, rights and privileges granted hereby are as follows (if less than all of 1-3 are granted, then check and initial applicable paragraphs):
Initial Overhead and/or Underground. The right from time to time to construct, install, operate and maintain, upon, over, under and across the Property described in Section C below, along a route to be selected by the Company which is generally shown on the attached drawing (which shows the general location of underground facilities, if any, by cross-hatching indicating an area not greate than ten feet (10") in width), all poles, towers, wires, conduits, fiber optics, cables, transclosures, transformers, anchors of concrete metal or other material, guy wires and other materials, appliances, facilities and other apparatuses of whatever type, whether now of in the future existing or known which are useful or necessary in connection therewith (collectively, "Facilities"), for the overhead and/or underground transmission and distribution of electric power and for overhead and/or underground communication service, and also the right to clear a strip extending fifteen feet (15") to either side of the center line of the lines of poles and keep it cleared of all trees undergrowth or other obstructions; further, the right to trim and cut and keep trimmed and cut all dead, weak, leaning or dangeround trees or limbs outside of the thirty foot (30") strip which, in the sole opinion of the Company, might endanger, interfere with or fauther poles, lines, or other appliances of the Company.
2. Line Clearing. The right to cut and trim and to keep cut and trimmed, and remove all dead, weak, leaning or dangerous tree or limbs, which, in the Company's sole discretion, now or may hereafter endanger or interfere with the electric transmission lines telephone lines, poles, towers or other facilities of the Company or others now constructed, or which may hereafter be constructed, or adjacent to the Property described in Section C below, and also the right to clear a strip extending fifteen feet (15') to either side of the center line of the lines of poles and keep it cleared of all trees, undergrowth or other obstructions.
3. Guy Wire and Anchor. The right to implant, install and maintein and Property of the Property described in Section C below, and to construct, extend and the limit guy wires from such anchor(s) to structure now erected or hereafter to be erected on such Property of Property adjacent thereto, collectively, "Guy Wire Facilities"). In addition to the easements, rights and privileges granted in all or any of 1, 2, or 3 above, Grantor hereby grants to the Company all easement rights and privileges necessary or convenient for the full enjoyment and use thereof, including without limitation the right of ingress and egress to and fro the Company's Facilities and Guy Wire Facilities, as applicable, and the right to excavate for installation, replacement, repair and removal thereof; at also the right to cut, remove and otherwise keep clear any and all structures, obstructions or obstacles of whatever character, on, under and above sa Facilities and Guy Wire Facilities, as applicable.

GENERAL In the event it becomes necessary or desirable for the Company to move any of its Facilities in connection with the construction or improvement of any public road or highway in proximity to its Facilities, Grantor hereby grants to the Company the right to relocate its Facilities said Property, provided, however, the Company shall relocate its Facilities at a distance no greater than ten feet (10') outside the boundary of the right of way of any such public road or highway as established or re-established from time to time. In the event that none of options 1 through 3 in Section above are marked, then Grantor hereby grants all easements, rights and privileges described in such option 1. This grant and agreement shall be bindit upon and shall inure to the benefit of Grantor, the Company and each of their respective heirs personal representatives, successors and assigns and two words "Company" and "Grantor" as used in this instrument shall be defined to include the heirs, personal representatives, successors and assigns of suparties.
