WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of NINETY EIGHT THOUSAND & NO/100---- (\$98,000.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Larry C. Hubbard and wife, Janice L. Hubbard (herein referred to as grantors), do grant, bargain, sell and convey unto Jacques P. Surcouf and wife, Annette U. Surcouf (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 20, in Block 5, according to the survey of Southwind, Fourth Sector, as recorded in Map Book 7 page 97 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama. Mineral and mining rights excepted.

Subject to existing easements, current taxes, restrictions, set-back lines and rights of way, if any, of record.

\$68,000.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.
