Councilman Stephen D. Cowart introduced the following
Resolution, which was read in full and considered:

RESOLUTION

WHEREAS, T. W. Lawrence and wife, Pauline Lawrence, John L. Davis and wife, Elizabeth V. Davis have filed a petition and written declaration of vacation of a portion of a twenty foot alley, as shown by map of Calera, Shelby County, as surveyed by John H. Dunstan on October 1, 1886, requesting the Mayor and Town Council to give their consent for the vacation of said portion of said street in the Town of Calera, Alabama, and

WHEREAS, the Mayor and Town Council desire to give their consent for the vacation of said portion of said twenty foot alley hereinafter described;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF CALERA, ALABAMA, AS FOLLOWS:

That the Mayor and Town Council do hereby give their assent for the vacation of a part of twenty foot alley as shown in the map of Calera, Shelby County, Alabama as surveyed by John H. Dunstan on October 1, 1886, said part of said twenty foot alley to be vacated being described as follows:

A part of a 20 foot alley extending Southerly through the middle of Block 27 according to said map which said alley is more particularly described as follows: Commence at the NE corner of Lot 21, Block 27 and run thence Southerly along the East boundary of Lots 21 through 29, (inclusive), to the North boundary of 12th Avenue; thence Southerly along the North boundary of 12th Avenue to the SW corner of Lot No. 1; thence Northerly along the West boundaries of Lots 1, 2, 3 and 4 to a point due East of the NE corner of said Lot 21; thence West 20 feet to point of beginning.

BE IT FURTHER RESOLVED, That a copy of this Resolution certified by the Town Clerk be filed and recorded in the Probate Office of Shelby County, Alabama, with the Petition and Written Declaration of Vacation of Certain Alley.

Said Resolution was read at length and thereupon Councilman Jack Martin moved that unanimous consent of the Mayor and Council be given for the immediate consideration and action upon said Resolution, which motion was seconded by Councilman W. B. Watts Jr.. Said motion for unanimous consent was submitted
