"Gemological Certificate" means the certificate issued by an independent gemological laboratory which accompanies the Memo and describes any loose diamonds which may be included in shipments of Consigned Merchandise to Consignee.

"Memo" means the document, labelled "Memo" or "Work Receipt" which accompanies each shipment of Consigned Merchandise to Consignee and generally describes and identifies the items of Consigned Merchandise contained in each shipment.
