business and personal affairs, and for recovering, obtaining and holding all real or personal property including debts, interest, demands, duties, sums of money or any other things whatsoever, as aforesaid, that are thought to be due, owing belonging or payable to me in my own right or otherwise; to prepare, sign and file joint or separate income tax returns and declarations of estimated tax returns and declarations of estimated tax for any year or years; to prepare, sign and file gift tax returns with respect to gifts made by me for any year or years; to consent to any gift and to utilize any gift splitting provisions or other tax election; and to prepare, sign and file any claims for refund of any tax year; to have access at any time or times to any safety deposit box rented by me, wheresoever located, and to remove all or any part or contents thereof, and to surrender or relinquish said safety deposit box, and any institution in which such safety deposit box may be located shall not incur any liability to me or my estate as a result of permitting my attorney-in-fact to exercise this power; and to do, execute, perform, and finish for me and in my name all things which my attorney-in-fact shall deem necessary or appropriate, in and about or concerning my property or any part thereof.

This power of attorney is a durable power of attorney. This power of attorney shall not be affected by disability, incompetency, or incapacity of the principal. Nor shall this power of attorney be affected by the lapse of time. It is my intent that the authority conferred herein shall be exercisable notwithstanding my physical disability or mental incompetence.

I may revoke this power of attorney at any time by written instrument delivered to my attorney-in-fact.

To induce any third party to act hereunder, I hereby agree that any third party receiving a duly executed copy or facsimile of this power of attorney may act hereunder, and that revocation or termination hereof shall
