If and when this is a second mortgage, it is further understood and agreed that this mortgage is subordinate to any prior mortgage only to the extent of the current balance now due on the debt secured by said prior mortgage. The within mortgage will not be subordinated to any advances secured by the above described prior mortgage, if said advances are made after the date of the within mortgage.
