

MODIFICATION AGREEMENT

THIS AGREEMENT of Modification made and entered into by and between **Ronnie Morton**, a married man (hereinafter referred to as "Borrower") and **First National Bank of Columbiana** (hereinafter referred to as FNBC), on this the 1st day of June, 1995.

W I T N E S S E T H :

WHEREAS, Borrower on the 1st day of December, 1994, executed to FNBC a Note in the principal sum of \$76,000.00, ("Note"), which Note is secured by a mortgage conveying certain property situated in Shelby County, Alabama, which mortgage is recorded in the Probate Office of said County, Instrument Number 1994-35578 ("Mortgage"), reference being hereby made to the Mortgage for a particular description of the Note and the description of the property securing the payment of the Note (the Mortgage Property") and

WHEREAS, the Borrower is the owner of the Mortgage Property, and has requested to increase said amount from \$76,000.00 to \$92,000.00, (an increase of \$16,000.00) and

WHEREAS, the Borrower has requested a 6 month extension of said loan extending to December 1, 1995, which sum is to be secured by the Mortgage, and

WHEREAS, there are no liens or encumbrances against the mortgage property, or judgments against the Borrower, and

WHEREAS, the amount due under the Note and Mortgage is \$92,000.00. As of this date, the sum of \$66,102.92 has been advanced out of the total amount available.

WHEREAS, Borrower is desirous of paying the balance of the Note and Mortgage in accordance with a loan plan of FNBC, and the rules and regulations governing same;

NOW, THEREFORE, in consideration of the mutual benefits to flow to each of the parties hereto, the undersigned hereby agree and covenant as follows, viz:

1. The Borrower agrees to pay the indebtedness secured by the Mortgage in the amount of \$92,000.00 in accordance with the

following loan plan of FNBC.


(a) Interest shall accrue on the amount of the unpaid principal at the rate of 12.00% and shall be paid monthly.

(b) The entire principal and any interest thereon shall be due and payable on the 1st day of December, 1995.

2. The mortgage will secure the extension as a valid first lien against the mortgage property.


3. Except as modified by this Agreement, all conditions, terms obligations, agreements and stipulation made in the Mortgage and Note shall remain in full force and effect.

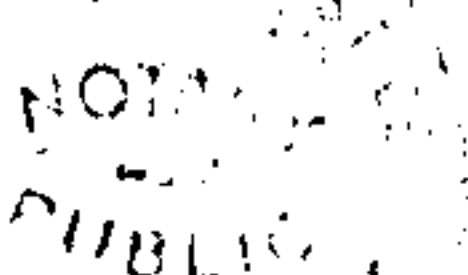


