Gordon the following described real estate situated in Shelby County, Alabama, to wit:

The right of way of the Columbiana and Chelsea public road, as now used, running in a North-easterly direction from station 10 X 00, as now staked and confined between the North line of the tract of land known as Ed Collier's property, and the present crossing of said Columbiana and Chelsea public road over the Southern Railway Company's tracks, 327 feet Northeast of the Railroad crossing, as now staked for the new Columbiana and Chelsea Highway, and being a part of the Northeast Quarter of the Southeast Quarter of Section 23, and a part of the Northwest Quarter of the Southwest Quarter of Section 24, all in Township 21, Range 1 West, in Shelby County, Alabama, it being the intention of the grantor here to convey to the grantees herein all of the right of way of the Columbiana and Chelsea public road as it is now used, lying between the above described dimensions, the grantees herein having heretofore conveyed to Shelby County, Alabama, a right of way over and across their lands for the new Columbiana and Chelsea Highway as now surveyed and located.


