KNOW ALL MEN BY THESE PRESENTS, That in consideration of **ONE HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED Dollars and No/100's (\$162,500.00)** to the undersigned grantor, **VISION HOMES, INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of which is hereby acknowledged, the said **GRANTOR** does by these presents, grant, bargain, sell, and convey unto **TIMOTHY S. MCDONALD and DEANNA N. MCDONALD** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama:**

Lot 9A, according to a Resurvey of Lots 8 and 9, Yellowleaf Ridge Estates, as recorded in Map Book 19, Page 135, in the Probate Office of Shelby County, Alabama.

Subject to:

Ad valorem taxes for 1995 and subsequent years not yet due and payable until October 1, 1995. Existing covenants and restrictions, easements, building lines, and limitations of record.


