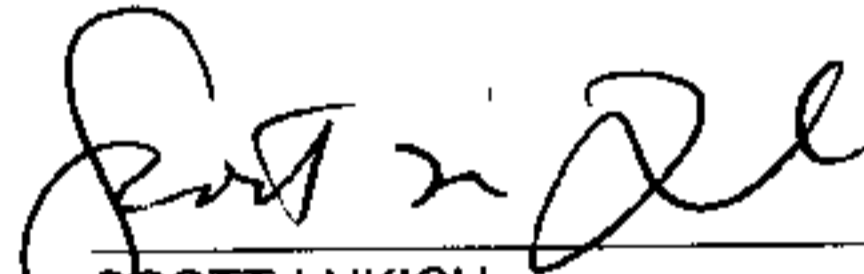
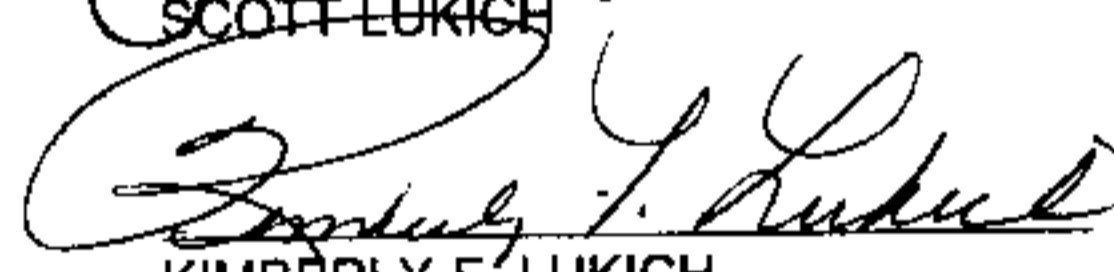
Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.

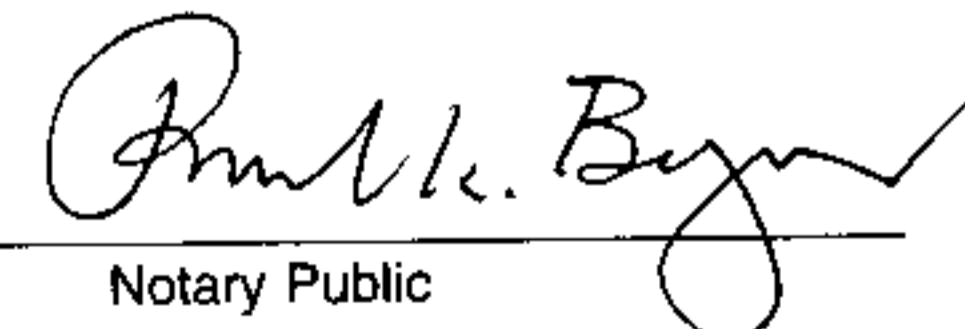
