Commence at the Southeast corner of the NW 1/4 of SE 1/4 of Section 26, Township 20, Range 3 West; thence run along the South line of said 1/4 - 1/4 Section a distance of 690.41 feet to the point of beginning; thence continue 108.73 feet to a point; thence turn right 89 deg. and run North a distance of 451.49 feet to a point; thence turn right 90 deg. 59 min. 28 sec. and run East a distance of 141.71 feet to a point; thence turn right 93 deg. 11 min. 28 sec. and run South a distance of 452.14 feet to the point of beginning.
