This Quitclaim Assignment and Bill of Sale ("Assignment") is executed and delivered from the parties executing at the foot of this Assignment, as Assignors, in favor of the bankruptcy estate of McKENZIE METHANE CORPORATION, a Texas corporation ("MMC"), represented by Robert E. Ogle, duly appointed trustee of said bankruptcy estate in Case Number 94-42758-H2-11, United States Bankruptcy Court, Southern District of Texas, as Assignee.

W I T N E S S E T H:

WHEREAS, MMC filed a voluntary petition for relief under Chapter 11 of Title 11 of the United States Code on April 20, 1994 which became Case No. 94-42758-H2-11 in the United States Bankruptcy Court for the Southern District of Texas (the "Court"); and

WHEREAS, on July 6, 1994, Robert E. Ogle was appointed Chapter 11 Trustee for the Estate of McKenzie Methane Corporation; and

WHEREAS, within the bankruptcy proceedings there arose disputes between the said Trustee and the Assignors concerning the present or former interest claimed by the Assignors in certain of the oil and gas interests and related property of MMC (the "Properties" as hereafter defined); and

WHEREAS, pursuant to that certain Order Approving Phase I of Trustee's Settlement and Compromise with Michael McKenzie, McKenzie Family Members and McKenzie Interests entered by order of the Court on May 8, 1995 (the "Phase I Order"), a copy of which is attached hereto as Exhibit "A" and incorporated herein for all purposes, Assignors have agreed to execute and deliver this instrument;

NOW THEREFORE THE PARTIES DO HEREBY AGREE AS FOLLOWS:

Assignors, in accordance with the terms of the Phase I Order and by these presents, RELINQUISH, GRANT, BARGAIN, SELL, CONVEY, ASSIGN, TRANSFER, SET OVER, QUITCLAIM and DELIVER unto MMC, as Assignee, any and all of the interest which Assignors might have or claim in and to the following properties (the "Properties"):

A. All of Assignors' right, title, interest and operating rights in and to the real property and interests in crude oil, condensate, natural gas, coal bed methane and other hydrocarbons and other minerals or materials of every kind and description described on Exhibit "B" hereto, and any rights that arise by operation of law or otherwise in all properties and lands pooled, unitized, communitized or consolidated with such properties and interests (the "Oil and Gas Properties").

B. All wells located on the Oil and Gas Properties, whether producing, operating, shut-in, temporarily abandoned, abandoned, standing or otherwise (the "Wells").

C. All severed crude oil, condensate, natural gas, coal bed methane and other hydrocarbons and other minerals or materials of every kind and description produced or to be produced at any time from the Oil and Gas Properties.

D. All physical facilities or interests therein that are used or held for use in connection with the ownership or operation of the Oil and Gas Properties and Wells (the "Equipment").

E. All water disposal wells, rights of way, easements and other real property interests and appurtenances comprising any coalbed methane gathering system and/or pipeline or water disposal systems utilized in connection with the Oil and Gas Properties or Wells together with all dehydrators, tankers, separators, drips, valves, meters, cathodic protection systems, pumps, and other fixtures and improvements used in connection therewith.

F. All (a) contracts and agreements that relate to the Properties and; (b) governmental, tribal or other permits and licenses; (c) easements and rights-of-way used or held for use in connection with the Oil and Gas Properties; and (d) all agreements, contracts, amendments, ratifications or extensions pertaining to the foregoing (the "Contracts").

TO HAVE AND TO HOLD all and singular the Properties, together with all rights, titles, interests, estates, remedies, powers and privileges thereto appertaining unto Assignee and its respective successors, legal representatives and assigns forever.

This Assignment is made without warranty of title, either expressed or implied, and with full substitution and subrogation of Assignee in and to all covenants and warranties by others heretofore given or made in respect of the Properties or any part thereof. Assignors agree to execute and deliver all further conveyances, transfer orders, releases and such other instruments

as may be necessary or appropriate to carry into effect the intention of this Assignment and of the Phase I Order.

This Assignment may be executed in any number of counterparts and each of such counterparts shall for all purposes be deemed to be an original, and all such counterparts shall together constitute but one and the same Quitclaim Assignment and Bill of Sale.

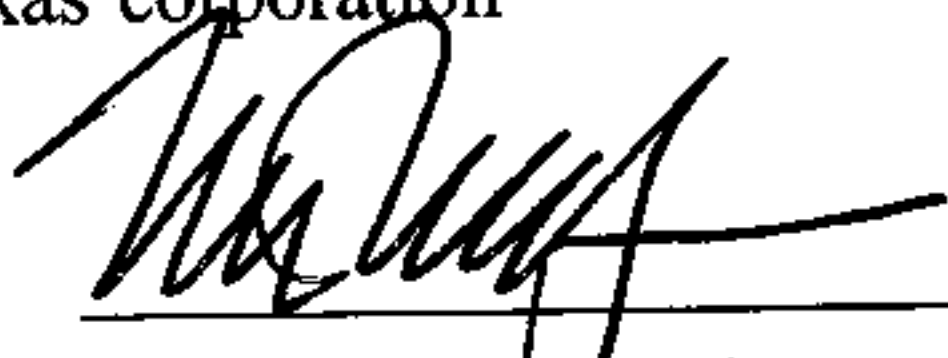

**ORDER APPROVING PHASE I OF TRUSTEE'S
SETTLEMENT AND COMPROMISE WITH MICHAEL MCKENZIE,
MCKENZIE FAMILY MEMBERS AND MCKENZIE INTERESTS**

CAME ON FOR CONSIDERATION the Expedited Motion to Compromise Controversy with Michael McKenzie, the McKenzie Family Members and the McKenzie Interests (Phase I - the Walker Flats and La Plata Pipeline Adversary Proceedings) (the "Motion") filed by Robert E. Ogle (the "Trustee"), Chapter 11 Trustee of the bankruptcy estate (the "Estate") of McKenzie Methane Corporation (the "Debtor"). After considering the Motion and all objections thereto, the Court is of the opinion that, under the circumstances notice of the Motion is proper and satisfies the requirements of the Bankruptcy Code, the Federal Rules of Bankruptcy Procedure and the Local Rules for the United States Bankruptcy Court for the Southern District of Texas and that the requested relief is meritorious and should be granted. Accordingly, it is therefore

ORDERED that all capitalized words in this order shall have the same meaning given to those words in the Motion unless otherwise defined herein. It is further

ORDERED that Phase I of the Trustee's compromise and settlement with McKenzie, the McKenzie Family Members and the McKenzie Interests is hereby approved. It is further

ORDERED that the parties to the Walker Flats Adversary Proceeding and the La Plata Pipeline Adversary Proceeding shall cause the agreed judgments (the "Agreed Judgments") in the form attached to the Motion as Exhibits "B" and "C" to be filed in the Walker Flats Adversary Proceeding and the La Plata Pipeline Adversary Proceeding. It is further

ORDERED that any transfers of the Walker Flats Wells and the La Plata Pipeline from the Debtor and/or La Plata Pipeline Company ("LPC") to McKenzie Energy Corporation ("MEC") and any subsequent transfers of the Walker Flats Wells and the La Plata Pipeline from MEC to McKenzie Energy U.S., Inc. ("MEUS") are hereby void ab initio. It is further

ORDERED that McKenzie, the McKenzie Family Members, and the McKenzie Interests shall relinquish by conveyance to the Estate all right, title, interest and/or claim to any well, lease or pipeline or lease or well equipment, gas, water or electric gathering disposal or transmission facilities or other infrastructure facilities in which and to the extent the Debtor, LPC, MEC, or MEUS has ever owned or claimed any interest. It is further

ORDERED that McKenzie, the McKenzie Family Members and McKenzie Interests shall execute any and all documents as may be reasonably necessary as requested by the Trustee in order to effect such conveyances to the Estate. It is further

ORDERED that this Compromise and Settlement is without prejudice to the rights of all MEC, MEUS and LPC creditors (other than McKenzie, the McKenzie Family Members and the McKenzie Interests) to assert valid claims, liens, interests and encumbrances if any. However, the Trustee (and all other parties entitled to object to

claims pursuant to 11 U.S.C. § 502) specifically retain all rights to dispute or object to and to seek to avoid any or all such claims, liens, interests and encumbrances as such rights may exist under the Bankruptcy Code or any other applicable law. It is further

ORDERED that McKenzie, MEC, MEUS, and LPC shall file a sworn statement as to the name and address of all MEC, MEUS and LPC creditors and the Trustee shall mail written notice to such parties of the June 12, 1995 bar date for the filing of claims in this bankruptcy case no later than May 9, 1995. It is further

ORDERED that the aggregate amount of the valid claims, liens, interests, and encumbrances, if any, shall not exceed the aggregate value of the Walker Flats Wells and the La Plata Pipeline. It is further

ORDERED and expressly agreed and recognized by McKenzie, the McKenzie Family Members and the McKenzie Interests and their privies that any *res judicata* and/or collateral estoppel and/or estoppel by judgment effect of this order and the Agreed Judgments is limited solely to the following findings: (1) that the MMC-MEC and MEC-MEUS Assignments (as defined in the Agreed Judgments) are void due to MEC and MEUS's failure to obtain the requisite approval from the Southern Ute Indian Tribe and the Bureau of Indian Affairs, thereby causing the mineral leases, wells, easements and other property described in said Assignments, together with all appurtenances thereto, including the physical pipeline to be property of the Estate and (2) that the easements, wherever located, in the name of the Debtor and/or LPC, together with any appurtenances thereto, including, but not limited to the physical pipeline, are property of the Estate. It is further

ORDERED and expressly agreed and recognized by McKenzie, the McKenzie Family Members and the McKenzie Interests and their privies that this order and the Agreed Judgments shall have no *res iudicata* and/or collateral estoppel and/or estoppel by judgment effect upon any other claims and/or causes of action that were raised in the Walker Flats and La Plata Pipeline Adversary Proceedings (alter ego, single business enterprise, fraudulent transfers and suit for accounting) or that could have been raised in the Walker Flats and La Plata Pipeline Adversary Proceedings or any other adversary proceeding, whether filed or to be filed (which would include any cause of action stated in Cause No. 77130 styled *Kukul, Inc. et al. vs. McKenzie Methane Corporation et al.* in the 268th Judicial District Court of Fort Bend County, Texas and subsequently removed and currently pending in the United States Bankruptcy Court for the Southern District of Texas, Houston Division as Adversary Proceeding No. 94-4347 and/or any other cause of action under any applicable law)
