**TO HAVE AND TO HOLD,** To the said Grantee, his, her or their heirs and assigns forever.

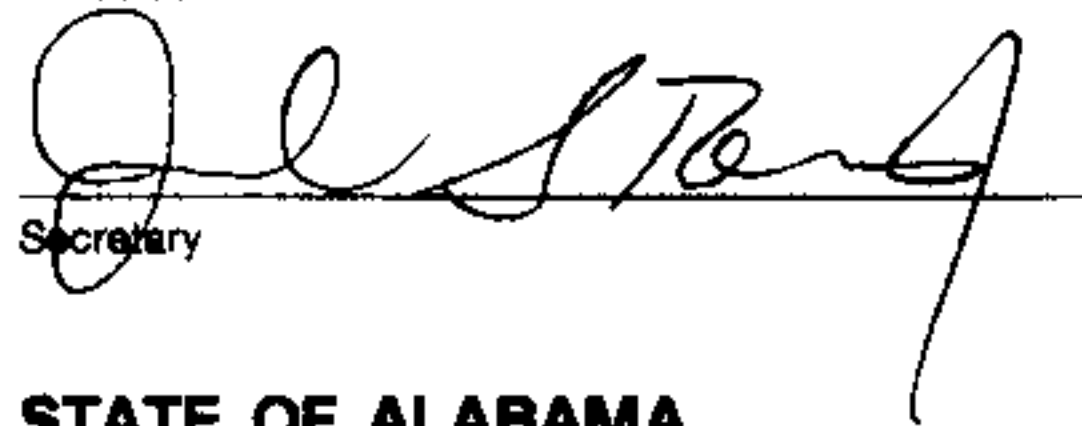

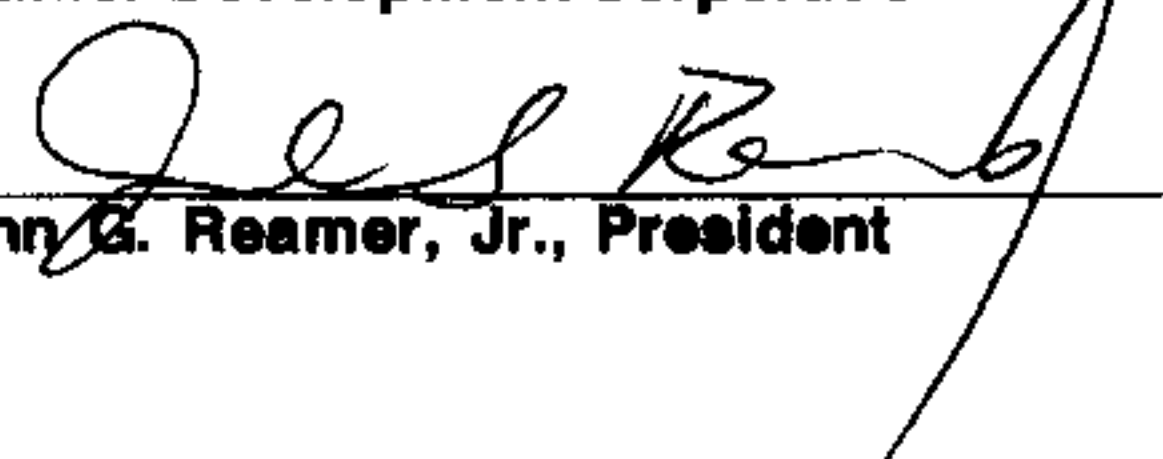
