KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE HUNDRED NINETY-EIGHT THOUSAND Dollars and No/100's (\$198,000.00) to the undersigned grantor, MEGA BUILDERS, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell, and convey unto DAVID D. STAFFORD and PATRICIA A. STAFFORD (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama:

Lot 1, according to the Survey of Shadow Brook as recorded in Map Book 6, Page 102 A & B, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to:

Ad valorem taxes for 1995 and subsequent years not yet due and payable until October 1, 1995.
