KNOW ALL MEN BY THESE PRESENTS, That in consideration of **ONE HUNDRED FIFTY-TWO THOUSAND Dollars and No/100's (\$152,000.00)** to the undersigned grantor, **SPRATLIN CONSTRUCTION CO., INC.**, a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell, and convey unto **CRISTA D. HAMILTON and STEVE RANDY HAMILTON** (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**:

Subject to:


Ad valorem taxes for 1995 and subsequent years not yet due and payable until October 1, 1995.


