

WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Two Hundred Seventy Five Thousand and no/100 Dollars (\$275,000.00) to the undersigned Grantors, **Ralph F. Noble and wife, Mary B. Noble** in hand paid by the GRANTEES, herein, the receipt whereof is acknowledged, we, **Ralph F. Noble and wife, Mary B. Noble**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **Patrick J. Fisher and Maniece N. Fisher**, (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama:

Lot 3, Block 4, Cherokee Hills, a subdivision according to the plat thereof recorded in Map Book 5, Page 3, in the Probate Office of Shelby County, Alabama.

Subject to easements, restrictions, limitations and rights of way of record.

A Purchase Money Mortgage in the amount of \$175,000.00 is filed simultaneously herewith.

TO HAVE AND TO HOLD to the said GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And we do for us and for our heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid that we will and our heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever against the lawful claims of all persons.

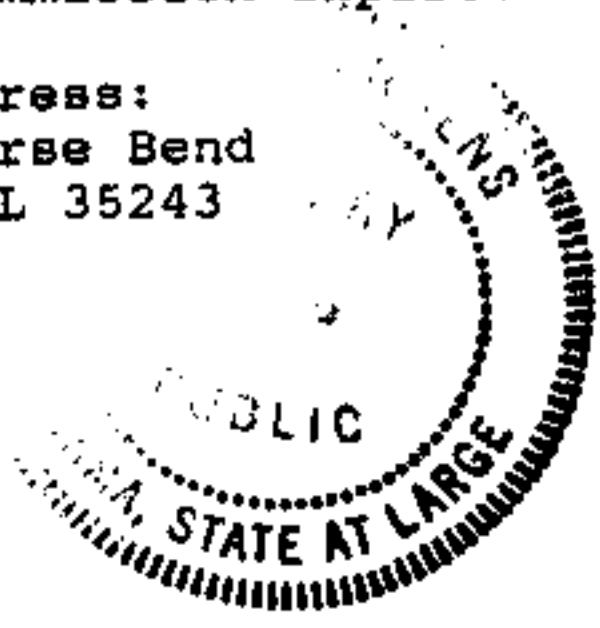
