

PARTIAL RELEASE OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, that:

OLON BELCHER AND HAZEL P. BELCHER, the present holders of a mortgage executed by CHARLES D. COOK, hereinafter referred to as the mortgagor, to OLON BELCHER AND HAZEL P. BELCHER, dated JANUARY 30 1993, and recorded on FEBRUARY 2 1993, in BOOK 089 PAGE 916 of the Records in the Office of the Probate Judge of Chilton County, Alabama, and recorded on FEBRUARY 2 1993, in INST # 1993-03028 of the Records of the Office of the Probate Judge of Shelby County, Alabama, and of a note for the principal sum of ONE HUNDRED - TWENTY NINE THOUSAND ONE HUNDRED - SEVENTEEN \$50/100 Dollars (\$129,517.50), the receipt of which is hereby acknowledged, does hereby release from the lien of said mortgage and hereby release and quitclaim to the said mortgagor, all right, title and interest in and to that portion of the land conveyed by said mortgage, situated in Chilton County and Shelby County, Alabama, and described as follows:

Beginning at the NW corner of the SW 1/4 of the NE 1/4 of Section 14, Twp. 24 N, R 12 E, and run in a southerly direction along the westerly line of said 1/4-1/4 section for 1129.23 feet to a point on the northwest right-of-way line of Chilton County Road No. 18; thence 56 degrees 02 minutes 55 seconds to the left in a northeasterly direction along said right-of-way for 100.00 feet to a point; thence 43 degrees 47 minutes 57 seconds to the left in a northerly direction for 1160.67 feet to a point; thence 83 degrees 38 minutes 02 seconds to the left in a westerly direction for 679.47 feet to a point on the westerly line of the NW 1/4 of the NE 1/4 of said section 14; thence in a southerly direction along said 1/4-1/4 section line for 75.00 feet to the point of beginning.

And the said OLON BELCHER AND HAZEL P. BELCHER do hereby constitute and appoint the Probate Judges of Chilton County, Alabama and Shelby County, Alabama its true and lawful agents and attorneys-in-fact, for them and in their names and stead, to enter upon the margin of the record of said mortgage satisfaction thereof as to the land above described, reserving in full force and effect the lien on the remainder of the premises described in said mortgage and not heretofore or hereby released, as security for the sum remaining due on said note and under said mortgage, and interest thereon.
