That in consideration of ONE HUNDRED FOURTEEN THOUSAND & NO/100---- (\$114,000.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEEES herein, the receipt whereof is acknowledged, we, Steve R. Buchanan and wife, Barbara O. Buchanan (herein referred to as grantors), do grant, bargain, sell and convey unto John E. Simons and wife, Katherine T. 
