WEBB and wife, CONNIE B. WEBB, (herein referred to as grantors, whether one or more) do grant, bargain, sell, and convey unto **JAMES W. CARMAN and CORRIE A. CARMAN** (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:


