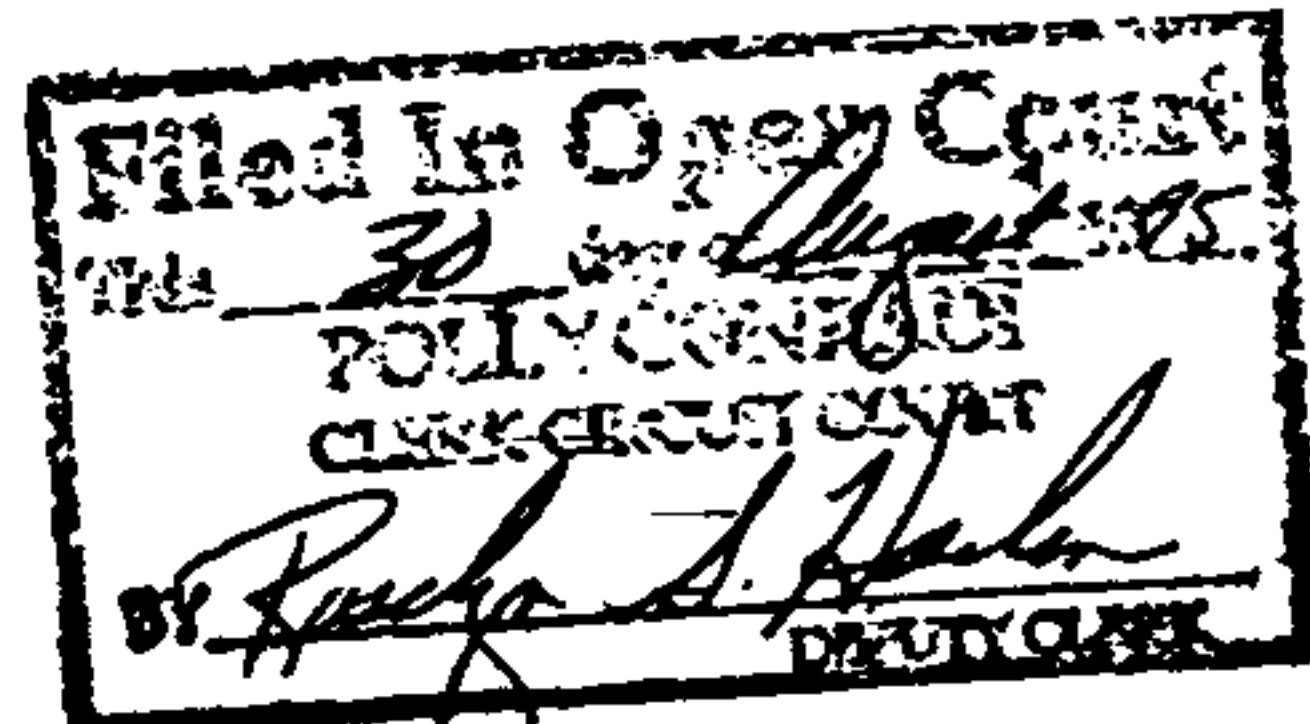

CONSENT JUDGMENT

WHEREAS, plaintiffs, Perry L. Savage and Kay W. Savage have filed suit against John T. Sumner, Jr. for amounts due and owing in connection with a Guaranty Agreement executed and delivered by Sumner to the Savages;

WHEREAS, John T. Sumner has agreed to settle the underlying dispute by agreeing to enter into a Consent Judgment against him and in favor of Perry L. Savage and Kay W. Savage.


IT IS HEREBY ORDERED AND ADJUDGED that Perry L. Savage and Kay W. Savage be and are, jointly and severally, hereby awarded judgment against John T. Sumner, Jr. on its claim herein;

IT IS HEREBY ORDERED AND ADJUDGED that Perry L. Savage and Kay W. Savage, jointly and severally, have and recover of John T. Sumner, Jr., in the amount of \$429,928.80, which is comprised of \$300,000.00 principal, accrued interest of \$124,928.80, and attorney's fees and costs of \$5,000.00. Interest will accrue from this day forward on the full amount of the judgment at the rate of interest provided from time to time pursuant to Alabama law; and

IT IS HEREBY ORDERED AND ADJUDGED that any payment received by Perry L. Savage and Kay W. Savage, jointly or severally, from any source to reduce the principal amount due under that certain Note referenced in the complaint in this case shall reduce the amount of this Judgment accordingly.

Each party shall bear its own costs of court.
