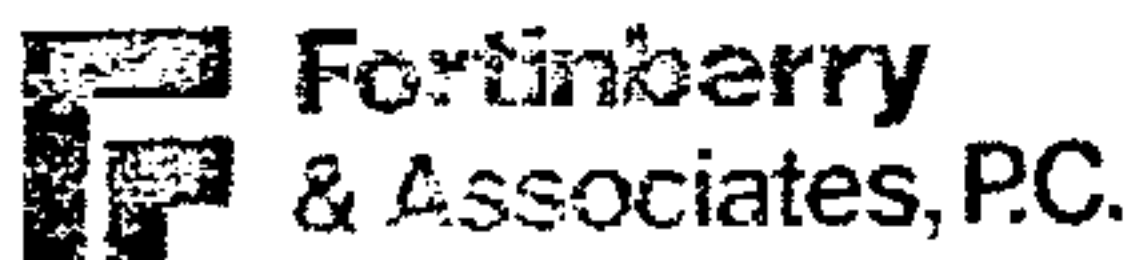

Dear Mrs. Hill

Per our recent meeting and subsequent telephone conversation regarding the referenced store location, I understand that you wish to add fourteen(14) track light units, each with three(3) low voltage lamps and that each track light unit will have a ceiling-mounted receptacle.

I also understand that you wish to add a total of twenty(20) wall-mounted receptacles at the standard mounting height above the floor, for the purpose of lamp displays. Further, I understand that you wish to construct nine(9) drywall partitions sized approximately 8'L x 6'H, each with wood baseboard, crown mould and possibly, a chair rail and/or window - painted or papered per your specifications.

Finally, you indicated that you wished to enclose a storage area at the rear of the store which would entail a new HM door frame, flush wood door and standard, matching hardware and approximately 100 SF of metal stud partition and drywall.

For the purpose of establishing a cost for work described above, we estimate the cost as follows:

14 track lights, installed
14 ceiling-mounted receptacles, installed
432 SF of finished drywall display partitions
20 wall-mounted receptacles, installed
New door frame and hardware
100 SF of storage room partition
