KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of **ONE HUNDRED SIXTY NINE THOUSAND NINE HUNDRED DOLLARS AND 00 CENTS (US\$169,900.00)** Dollars to the undersigned GRANTOR in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, **Cameo Construction Company, Inc., a Corporation** (hereinafter referred to as GRANTOR), does hereby grant, bargain, sell and convey unto **George C. Bartle and wife, Lydia L. Bartle**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in the County of Shelby and State of Alabama, to-wit:

Lot 4, according to Dailey's Re-Survey of Nevinshire Village, as recorded in Map Book 20, page 55, in the Probate office of Shelby County, Alabama.

This conveyance is hereby made subject to restrictions, easements and rights of way of record in the Probate Office of Shelby County, Alabama.

Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining in fee simple.

TO HAVE AND TO HOLD the same unto GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.
