ORDINANCE

AN ORDINANCE TO ALTER, RE-ARRANGE, AND EXTEND THE CORPORATE LIMITS OF THE TOWN OF WILTON, ALABAMA, SO AS TO EMBRACE AND INCLUDE WITHIN THE CORPORATE AREA OF SAID TOWN, ALL TERRITORY NOW WITHIN SUCH CORPORATE LIMITS, AND ALSO CERTAIN OTHER TERRITORY CONTIGUOUS TO SAID TOWN.

WHEREAS, a Petition signed by the owner of all of the land within the territory therein described and proposed to be annexed to the Town, together with a map of said territory showing its relationship to the corporate limits of the Town has been filed with the Town Clerk of the Town of Wilton, which said land is located and contained within an area contiguous to the corporate limits of the Town of Wilton, and

WHEREAS, the Town Council has determined and found that the matters set forth and alleged in said Petition are true, and that it is in the public interest that said property be annexed to the Town of Wilton.

NOW, THEREFORE, BE "IT ORDAINED by the Town Council of the Town of Wilton, Alabama, as follows:

SECTION 1. That said Council and Town of Wilton hereby assent to the annexation of the hereinafter described territory to the Town of Wilton, Alabama, the corporate limits of the Town to be extended and re-arranged pursuant to the provisions of Chapter 42, Article 2, Code of Alabama 1975, Sections 11-42-20 through 11-42-23, (as amended), so as to embrace and include said territory in addition to the territory already within its present corporate limits, within the corporate area of said Town, which said territory is not within the corporate limits or police jurisdiction of another municipality, and the new boundary line does not lie at any point more than half the distance between the old town boundary and the corporate boundary of any municipality. Said property is situated in the NW 1/4 of the SE 1/4 of Section 9, Township 24 North, Range 12 East, in Shelby County, Alabama, and being more particularly → Nidescribed as follows:

Begin at the NE corner of the NW 1/4 of the SE 1/4 of Section 9, Township 24 North, Range 12 East, said point being the POINT OF BEGINNING; thence S 1 deg. 13' 41" E a distance of 667.99'; thence S 85 deg. 47' 02" W a distance of 892.18', to a point on the Eastern right of way line of Shelby County Highway No. 73, said point on a curve to the right having a radius of 1950.50' and a central angle of 15 deg. 01' 27"; thence along said right of way line and the arc of said curve a distance of 511.46', said arc subtended by a chord which bears N 12 deg. 07' 54" E a distance of 510.01', to the curve's end; thence N 19 deg. 36' 08" E a distance of 269.79'; thence S 88 deg. 21' 54" E a distance of 678.03' to the Point of Beginning.
