Begin at the Southwest corner of the NW 1/4 of the SE 1/4 of Section: 36, Township 18 South, Range 2 West, Shelby County, Alabama, said point being on the West line of said Lot 1, Dewberry's Subdivision; thence from the West line of said 1/4-1/4 section turn an angle of 29 degrees 08' to the right in a Northeasterly direction and run 695.72 feet to a point; thence 95 degrees 21' to the right in a Southeasterly direction a distance of 108.82 feet to a point; thence 51 degrees 00' 30" to the left in a Northeasterly direction a distance of 145.36 feet to a point; thence 18 degrees 46° 45" to the right in an Easterly direction a distance of 78.28 feet to a point; thence 20 degrees 07' 12" to the left in a Northeasterly direction a distance of 70.31 feet to a thence 38 degrees 51' to the left in a Northeasterly direction a distance of 143.16 feet to a point on the Southwesterly right-of-way line of U.S. Highway No. 280; thence 92 degrees 59' 54" to the right in a Southeasterly direction along said right-of-way line a distance of 41.53 feet to a point; thence 79 degrees 04, 30% to the right in a Southwesterly direction a distance of 69.37 feet to the P.C.
