**ARTICLES OF ORGANIZATION**  
**OF**  
**SELF, HOWARD, and CASLOW, L.L.C.**

The undersigned, acting as the organizers of a limited liability company under the Alabama Limited Liability Company Act (the Act), hereby adopt the following Articles of Organization for Self, Howard and Caslow, L.L.C. (the Company).

**ARTICLE ONE**

The name of the Company is Self, Howard and Caslow, Limited Liability Company (LLC).

**ARTICLE TWO**

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act.

**ARTICLE THREE**

The Company is organized for the purpose of conducting business in the rendering of certified public accounting services for the benefit of the general public, businesses and other selected clients, and to perform all duties and business for which a certified public accounting firm may be lawfully organized under the Act.

**ARTICLE FOUR**

**ARTICLE SIX**

The initial members of the Company may admit additional members at such times and upon such terms and conditions as may be mutually agreed upon by the Company and the additional members. Only certified public accountants in good standing may be admitted, however, and then only upon the unanimous vote of the initial members.

**ARTICLE SEVEN**

The legal existence and business of the Company may be continued by the written consent of all the remaining members within 90 days after an event of dissociation of a member.

**ARTICLE EIGHT**
