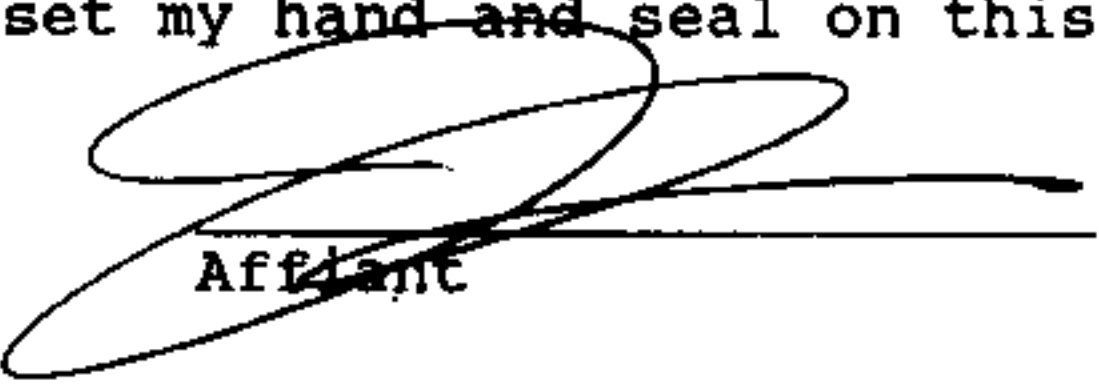

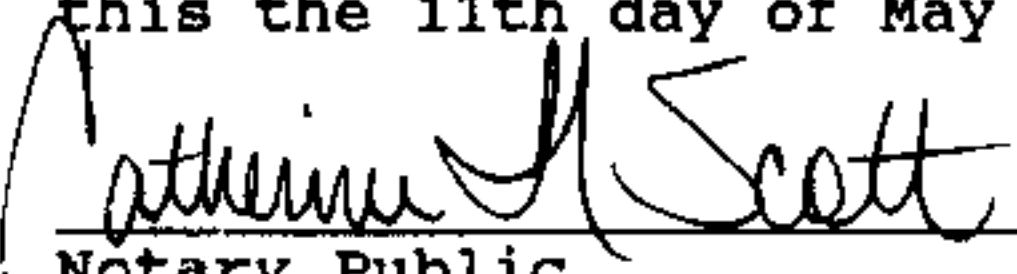
Said Satisfaction is signed by Alice Ann Vandiver, the daughter of John C. Lacey and Lillian S. Lacey, both deceased.
