KNOW ALL MEN BY THESE PRESENTS, That in consideration of Three Hundred Forty-four Thousand Sixty-one and 00/100 DOLLARS (\$344,061.00) to the undersigned grantor, Coventry Homes, Inc., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto Kevin T. Vivian and Susan C. Vivian (herein referred to as GRANTEEES) as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama:

Lot 32, according to the survey of Greystone, 7th Sector, Phase II, as recorded in Map Book 19 page 121 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

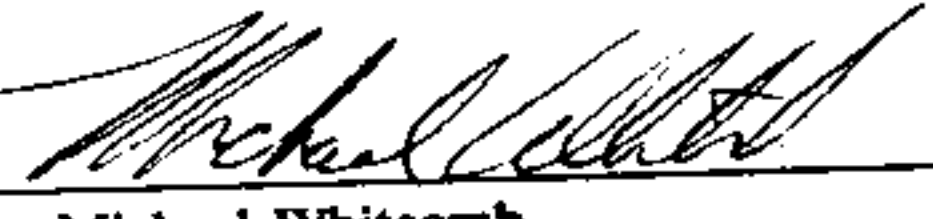
\$309,600.00 of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.

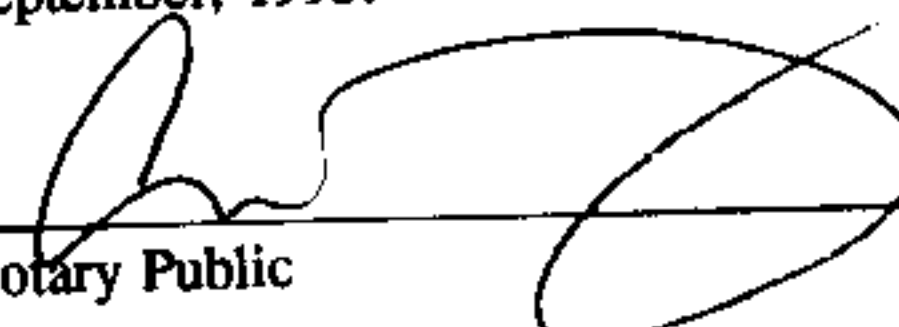
