

Last Will and Testament

OF

I, **FRANK ROOSEVELT DANIEL**, a resident of the State of Alabama, and over the age of nineteen (19) years, being of sound mind and disposing memory, do hereby make and publish this my Last Will and Testament, hereby revoking all former Wills and Codicils which may have been at any time heretofore made by me.

ITEM I DEBTS

I hereby direct that all of my just debts, funeral expenses, expenses of a last illness, if any, and the costs of administration of my estate be paid as soon after my death as practicable.

ITEM II PERSONAL PROPERTY AND ESTATE

All the rest, residue and remainder of my property, of every nature and description, real or personal, wherever located, specifically including insurance proceeds, retirement benefits and Social Security benefits, whether acquired before or after execution of this Will, I give, devise and bequeath to my wife, **BETTY CARROLL DANIEL**, to be hers, in fee simple, absolutely and forever. In the event of my wife's death, then, and in that event, I hereby give, devise and bequeath any and all mineral rights owned by me on any property in Shelby County, to the University of Alabama in Birmingham.

ITEM III APPOINTMENT OF EXECUTOR

I hereby nominate and appoint my husband, **BETTY CARROLL DANIEL**, as Executor of my estate and to serve as same without being required to furnish bond or security.

I hereby fully authorize and empower the Executor the full power to sell, lease, mortgage, pledge, invest, reinvest, exchange, manage, control, and in any way, use and deal with any and all property of my estate, without any application to any Court, or Judge thereof, for leave or confirmation, unless the same shall be expressly required by law.
