KNOW ALL MEN BY THESE PRESENTS, That in consideration of Two Hundred Seventeen Thousand Five Hundred and 00/100 DOLLARS (\$217,500.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, I/we Richard Scott Perkins and wife, Natalie C. Perkins, (herein referred to as grantors, whether one or more) do grant, bargain, sell, and convey unto Anthony Scott Ganier and Vanessa K. Simmons (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama:


\$203,150.00 of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.


