Commence at the Northwest corner of the Northeast 1/4 of the Southwest 1/4 of Section 5, Township 21 South, Range 1 East; thence run South along the West line of before stated 1/4-1/4 Section a distance of 375.00 feet; thence turn an angle of 90 degrees 24 minutes 16 seconds to the left and run a distance of 10.00 feet to the point of beginning; thence continue in the same direction a distance of 389.47 feet to the Northwest right of way line of Shelby County Highway No. 55 (40.00 feet from the center line); thence turn an angle of 141 degrees 00 minutes 21 seconds to the right and run along said right of way a distance of 20.93 feet to Highway P.T. Station 26-34.2; thence continue along a right of way curve (whose Delta Angle is 16 degrees 03 minutes 40 seconds to the left, Radius is 1,185.61 feet, Tangent is 166.95 feet, Length of Curve is 330.65 feet); thence turn an angle of 111 degrees 49 minutes 48 seconds to the right from tangent of said curve and run a distance of 270.73 feet; thence turn an angle of 33 degrees 37 minutes 47 seconds to the right and run a distance of 28.60 feet to the point of beginning.
