Pursuant to the Alabama Business Corporation Act, Sections 10-2B-10.01 and 10-2B-10.06, the undersigned corporation, **MDH ELECTRIC, INC.**, a corporation organized and existing under the laws of the State of Alabama, hereby submits the following:

1. The name of the corporation is **MDH ELECTRIC, INC.**
2. The Articles of Incorporation shall be amended as follows:

ARTICLE I of the Articles of Incorporation is hereby deleted in its entirety, and there is substituted in lieu thereof the following:

**"ARTICLE I**

The name of the Corporation shall be Power Resources, Inc., and any and all references to MDH Electric, Inc. shall hereafter be deemed to refer to Power Resources, Inc."

The above Amendment does not provide for an exchange, reclassification, or cancellation of issued shares.

3. The Amendment to the Articles of Incorporation was approved by a unanimous vote of the sole Director and the sole Shareholder, on the 8<sup>th</sup> day of November, 1995, on which date there were One Thousand (1,000) shares outstanding and entitled to vote thereon.

The within Articles of Amendment are being filed in the Office of the Judge of Probate of Shelby County, Alabama, for the purpose of effecting such amendment in accordance with the requirements of Code of Alabama 1975, Section 10-2B-1.25.

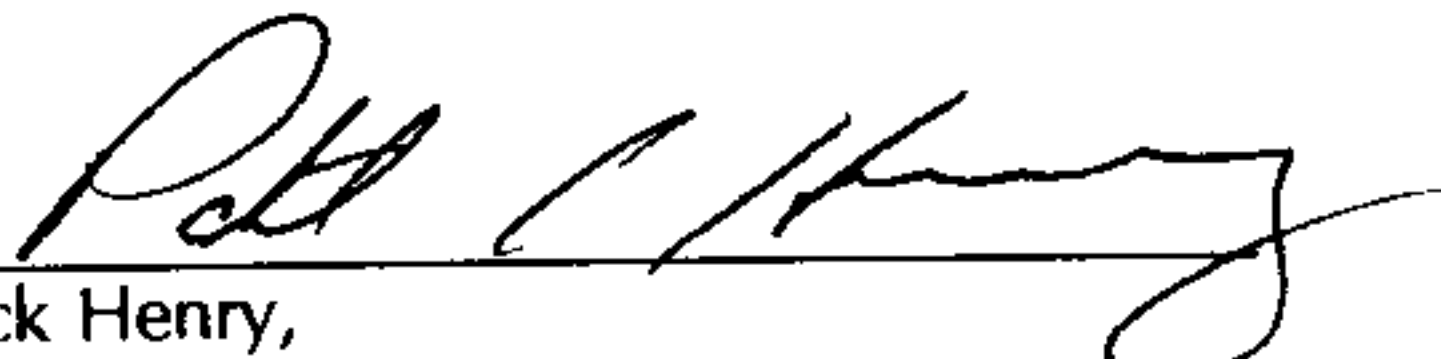

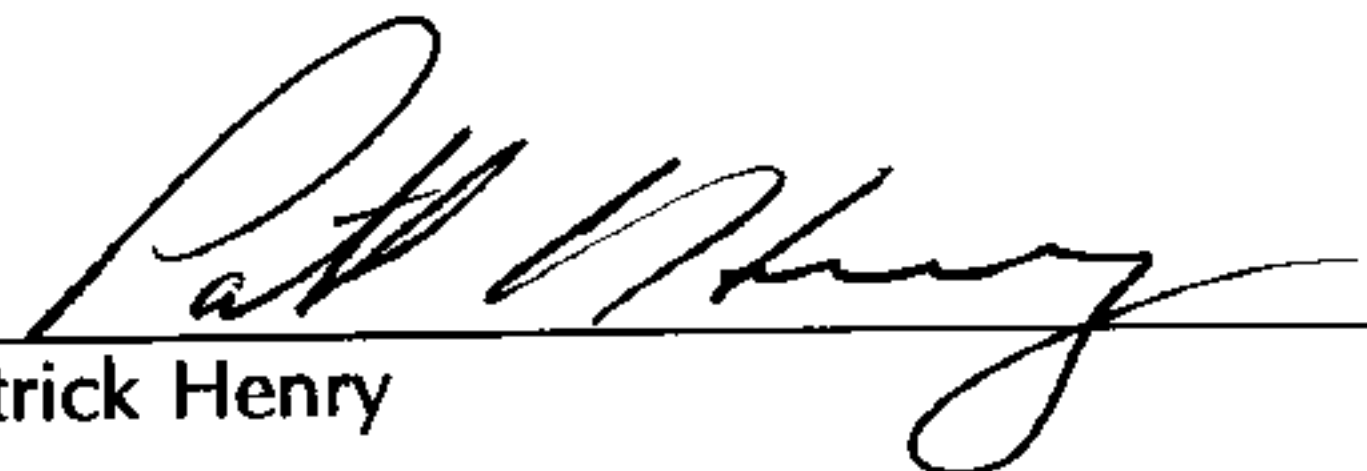
ARTICLE I of the Articles of Incorporation is hereby deleted in its entirety, and there is substituted in lieu thereof the following:
