VARIABLE RATE LINE OF CREDIT MORTGAGE

This Variable Rate Line of Credit Mortgage, made and entered into on NOVEMBER 3, 1995, by and between FATE BRYANT AND WIFE, DORIS BRYANT (bereinafter referred to as "Mortgagor", whether one or more) and the APCO EMPLOYEES CREDIT UNION (hereinafter referred to as "Mortgagoe"), whose address is 1606 7TH AVENUE NORTH, BIRMINGHAM, ALABAMA 35203 to secure the indebtedness of FATE BRYANT AND DORIS BRYANT (hereinafter referred to as "Borrower", whether one or more) to Mortgagee.

A. THE SECURED LINE OF CREDIT. The Borrower is now or may become justly indebted to the Mortgagee in the maximum principal amount of \$30,400.00. This indebtedness is evidenced by a certain open-end line of credit established by the Mortgagee for the Borrower pursuant to an Equity Line of Credit Agreement of even date herewith, (the "Credit Agreement"). The Credit Agreement provides for an open-end credit plan pursuant to which the Borrower may borrow and repay, and reborrow and repay, amounts from the Mortgagee up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.

B. RATE AND PAYMENT CHANGES. The Credit Agreement provides for finance charges to be computed on the unpaid balance outstanding from time to time under the Credit

Agreement at an adjustable annual percentage rate. The annual percentage rate may be increased or decreased based on changes in an index. C. MATURITY DATE.
