LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, Heather Whitestone, as principal ("Principal"), a resident of the State and County aforesaid, have made, constituted and appointed and by these presents do make, constitute and appoint my attorney, Charles J. Lorant, as my true and lawful agent or attorney in fact ("Agent") to do and perform each and every act, deed, matter necessary or required in and about my affairs as I might or could do in my own proper person, if personally present, to effectuate the limited, purpose specifically enumerated as follows:

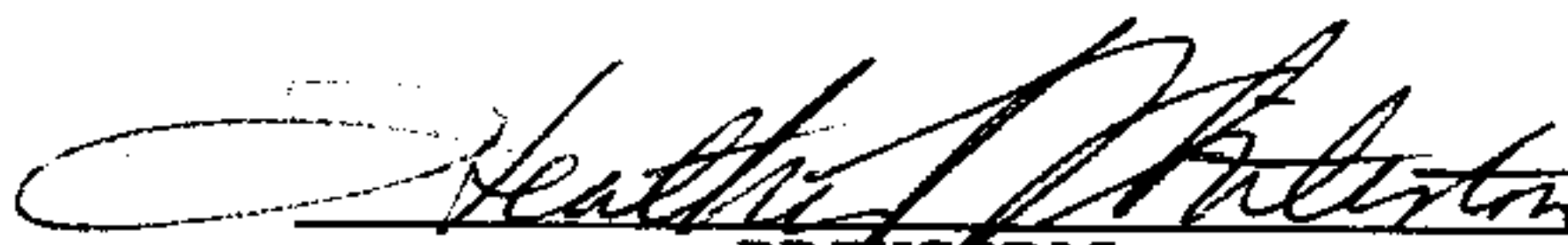

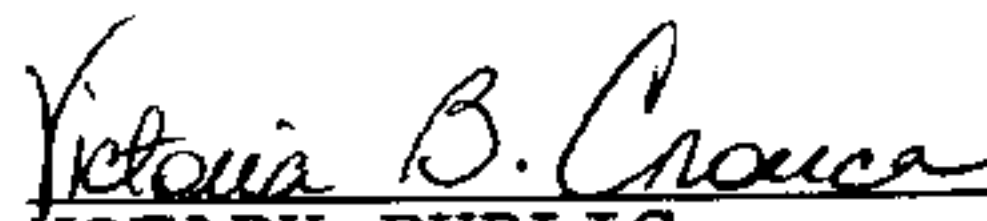
